Kaitlyn Wardle/Mountain Crisis Services gave the report. During public comment, thanks and support were expressed by Pete Judy/Chief Probation Officer and Chevon Kothari/Health and Human Services Agency Director.

Chair Menetrey presented the Proclamation to staff from Mountain Crisis Services.

F. Departmental Presentation

Walter Wall/District Attorney discussed the difficulty of domestic violence crimes and noted that he has been working with the Sheriff's Office to get a domestic violence specialist on staff.

Chevon Kothari announced that she just received word of winning a one million 33 thousand grant. She also passed out a flyer for the first ever Veterans Resource Fair on November 8th and extended thanks to the Lions Club as they will be serving lunch; announced that open enrollment for both Medi-Cal and Covered California will be coming up starting on October 15th, and advised that people needing help on health insurance can call her department; advised that Public Health has flu shot clinics coming up; and advised that Chrissie Doss was appointed as the Director of the Health Services division, that Baljit Hundal has been appointed as the Human Services Division Director, that Sara Landucci has been hired the new Strategic Communications Specialist and Public Information Officer, and that Michael Cornwell was just appointed as the Deputy Director of Administration. Ms. Kothari also reported that her predecessor Jim Rydingsword passed away the past weekend.

Supervisor Cann advised that the County received word yesterday of the award of a 6.3 million dollar grant to renovate side streets in downtown Mariposa from 3rd to 13th Streets as well as the Parking District parking lots, and which requires no matching funds from the County. Tara Schiff/Administrative Analyst/Economic Development Specialist discussed the history of the action. Dallin Kimble/County Administrative Officer (CAO) noted staff efforts in the matter. Mike Healy/Public Works Director advised that from 3rd Street to 12th Street, the project will include new curbs, new sidewalks, new streets, undergrounding of utilities, new lights, traffic studies, and ADA studies. He also noted that Mariposa Public Utility District (MPUD) was incorporated in the grant application for new water and sewer lines, as well. Mr. Healy also advised that, once completed, the project will save three to four million dollars in regular road and infrastructure improvements; noted that he plans on having a number of community meetings once the design consultant is on board. Mr. Healy also extended thanks to the CAO for his encouragement on the project.

Dallin Kimble/CAO advised that he received word this morning that the Planning Department also received a grant; and provided an update on the tree mortality project noting that as of a month ago there were about 945 trees remaining to be removed. Mr. Kimble also advised that the Technology Division has been working on getting computers on a maintenance cycle and will be replacing 92 desktops and 27 laptops that are older than seven years within the next few months; noted that those with both devices will be moved to a laptop and docking station; advised that the anticipated cost will be approximately \$44,000 for refurbished machines; and will, ultimately, move to where we are replacing devices every five years. Mr. Kimble also advised that the machines will be coming with the full Office Suite, and that credit goes to Anthony Rio/Technical Services Manager. Supervisor Smallcombe extended thanks to Mr. Rios and his staff for all of their efforts to keep the County's network safe.

Mike Healy noted that there are 14 projects under construction and announced

that they are beginning on Jerseydale Road this morning; advised that CAL OES is in town today to write the DSRs that FHWA has denied; and noted that he expects to have funding and go out for bid soon.

H. Regular Agenda Items

Discussion and Direction Regarding the Location of the Veterans Services Office (Supervisor Long)

Supervisor Long gave the staff report, noting that he brought this item because of concerns from our veterans. Chevon Kothari provided an overview of the history of the Veteran Services Office; discussed recent organizational changes; advised that the County receives funding for only 14 hours of a Veterans Service Officer; advised that many Veterans are eligible for other services and support; and discussed plans to increase capacity moving forward including cross-training of staff. During public comment, Steve Kuryla, Mick Herman, Al Handy, Michael Simpson, Bob Borchard, Jack Leard, Chuck Kendall, Bill Yaley, and Paul Aranguena discussed the special needs of the veterans and advocated for the Veterans Service Office to be located somewhere other than the Human Services building. Board discussion ensued regarding alternative locations including offices available at the VFW Building and the Fairgrounds. Supervisor Smallcombe discussed Veteran outreach and services and requested that the Veterans present considering becoming involved with the Veterans Collaborative meetings. Supervisor Jones expressed his support for the Veterans and their needs. Supervisor Cann noted that the Board has heard the concerns and noted that it sounds like the Human Services Director is working on a location outside of the Human Services Building. Chair Menetrey noted that the direction today is to find an alternate place for these services. Mr. Kothari advised that her department will work to locate a space where the Veterans feel comfortable and safe, but will need to bring an item back to the Board to fund the location. Supervisors Long and Menetrey discussed the need to get Veterans Service Officers out to all parts of the county.

DIRECTION: Health and Human Services is to locate an alternate location for Veterans Services.

that it is 85% contained; discussed staffing and equipment numbers; and extended thanks to all cooperators. Chief Quinn also noted that maps showing operations were available on the back wall of the Chambers. Supervisor Long extended thanks and discussed the need for prescriptive burns. Supervisor Cann discussed the difficulty caused by the terrain. Supervisor Jones discussed the use of the Fairgrounds for fire crews.

Doug Binnewies/Sheriff - Coroner - Public Administrator discussed the repopulation of 47 homes that had been evacuated, and extended thanks to the Sheriff's Department Public Information unit for their efforts to get information out. Sheriff Binnewies also discussed the Public Safety Power Shutoff (PSPS) event that was coordinated by Pacific Gas and Electric, noting that 1,812 hookups were deenergized, primarily in District 2; and extended thanks to the Health and Human Services Agency and the County Health Officer who worked to identify anyone who needed power for medical needs, as well as to the Sheriff's Office of Emergency Services.

Mike Healy/Public Works Director echoed that recognitions for the efforts of County Fire and the Sheriff's Department during these events. Mr. Healy also reported that yesterday the County received a little over 1.5 million in emergency work reimbursement for a number of projects; advised that he is working with the Chamber of Commerce to resurrect the Car Show and Cruise night that was canceled due to the fire. Supervisor Menetrey extended thanks for the spoiled food collection in Midpines. Supervisor Jones cautioned against using any food that had thawed and then refrozen.

Sarah Williams/Planning Director gave the staff report accompanied by a PowerPoint presentation. Clarification was required by Board members as to which would be the most cost effective change to implement.

Public comment opened. Bob Benson noted that the ranchers believe they are covered by the General Plan and urged removing the Ag Exclusive lands. Jill Harry discussed the timing of this item; requested that ag lands remain; urged additional review of the matter before decision is made; and requested that the bylaws be updated to include term limits and more category roles to ensure broad community representation. Wayne Kelly urged against any changes; discussed the advisory meeting; and remarked that he does not want to rush the decision because it took many years for the community to develop the plan. Debbie Lester/resident urged against any changes. Caroline Korn/resident urged against changes to the boundary or wording of the Catheys Valley Plan without careful study and provable criteria. Andrew Glikin/Raw Roots Farm Owner and Operator remarked on his confusion by the quick process and noted that he would like to hear what the change will do to the area. Scott Bening/rancher advised that it has been 7 years and none of the ranchers wanted to be included in the first place and urged accepting the committee's recommendation. Rick Lobaugh/resident noted he owns ag land that is also Williamson Act property; advised he was originally against it because it affected his ag land; objected that ag land and projects need to go through the advisory committee who do not understand ag property; noted that most of them have agreed that they do not want review authority over the ag properties and urged updating the bylaws to remove that review. Charli McCord/Catheys Valley Planning Advisory Committee (CVPAC) Chair discussed the history of this matter; noted that the committee members reached out to neighbors and others in an attempt to represent the community; advised that Ag Exclusive landowners, as well as some private owners, do not want to be in the boundary; noted that this issue has nothing to do with development and advised that the Mariposa County General Plan makes the focus on working lands a priority; and noted that there is a lot of misinformation out there and that she would focus on education the community should the Board decide to send this back to the CVPAC. Ken Wagner/resident and CVPAC member noted that in 2010 he and another 120 people were adamantly against any part of this plan but if you put it to a vote right now, 80% would want to get out; discussed misconceptions around the "drive-by" wording noting that there is not enough business for the restaurants that currently exist in Catheys Valley and that something needs to be done to allow them to do some capture of tourist business; noted that 26 square miles is too large; and advised of discussions that he has had with neighbors. Public comment closed.

Supervisor Long discussed the diversity of the committee; noted that the original plan that was presented to the Board was gutted; noted that four changes per year can be made to this plan under our rules; discussed the strategies used to engage the community and the manner in which the committee meetings were run; noted that he thinks Option 3 is radical and will cost money; advised that he supports the Ms. McCord's suggestion to bring this back to the community for more input; noted that

he supports property rights which are taken care of under the General Plan; and requested that the Board consider making amendments to the Catheys Valley Plan to allow for capture of tourist dollars. Board discussion ensued with Supervisor Cann noting that the Board's intent in 2012 was to remove perceived oversight from the ag land.

ACTION: The Planning Department is authorized to start the process of changing the language of the CVPAC Bylaws to remove all responsibility for ag lands; the matter of shrinking the boundary is to be sent back to the CVPAC; the proposed language regarding the capture move forward; and moving forward with this will be at the discretion of the Planning Director.

DIRECTION: The timing for these actions is entirely at the discretion of the Planning Director, and the project will be noted in her upcoming Work Plan as a Priority 3.

Receive a Presentation, Followed by Discussion and Possible Direction to Public Works Regarding Potentially Expanded Activities of the Butterfly Days Festival (Supervisor Cann)

Kevin Cann gave the staff report noting that since the County takes on a large degree of liability, he wanted to bring this discussion and direction as the Festival chairman has more planned for this year. Supervisor Cann then introduced Bill Lowe/Mariposa Butterfly Festival Chairman who screened his new movie, Ranchers and Packers. Mr. Lowe also discussed the Festival and advised that this year he will have jets doing a fly-over at 10:10 AM; and advised that he would like to have a mini round-up along the parade route to honor our ranchers, using ranchers and cattle and ranchers from the Chowchilla Stampeded to honor our ranching history. Public comment opened. Art Richards/rancher provided more information about the cattle that will be used and the methods to coax and control them. Scott Fiester extended kudos for the film; discussed the iconic nature of the Butterfly Festival; and spoke in

favor of diversifying the festival events. Ann Hart/Festival Committee member discussed a new educational feature that will be available during the Butterfly Festival. Public input closed. Board discussion ensued. Supervisor Cann requested input from the Public Works. Mike Healy/Public Works Director discussed his fears regarding liability issues last year, and asked that Mr. Lowe get to him to start the process early. Art Richards noted that the local insurance agent also insures the Chowchilla Stampede and commented that this is looking at minimal cost and heavily-controlled.

2. Human Resources RES-2019-703

Approve a Salary Adjustment for Specified Elected and Appointed Department Heads Effective July 1, 2019, Unless Otherwise Noted 4/5ths Vote Required

Kim Williams/Human Resources Director gave the staff report. Public comment opened. Public comment opened. Lorraine Freeman spoke against the increases noting that District 2 is an impoverished district and could use more transit and assistance. Jeanetta Phillips inquired why Merced and Madera counties were included when they have larger populations. Unknown gentleman inquired when the medical clinic in Coulterville will reopen. Public comment closed.

Kim Williams responded that Merced and Madera were included because they are direct competition for our employees. Supervisor Menetrey advised that the staff report noted that the unions agreed to these counties. Supervisor Jones recounted what the Healthcare District CEO had reported this morning. Mike Healy/Public Works Director noted that a transit hearing is held annual to identify unmet needs but, HHSA has been working on getting more services in the meantime. Supervisor Long suggested that Tuolumne should also have been included. Dallin Kimble discussed past recruitments; noted that some of the department heads have taken on new responsibilities; and argued in favor of market-based adjustments. Board discussion ensued regarding the study from Bryce Consulting, the meetings that had been held with the department heads, the fluctuations in the Consumer Price Index (CPI), and the need for ranges or steps like other employees. Supervisor Long noted that his biggest concern is keeping the department heads and elected official whole, and suggested that the minimum increase should be 15% given that CPI since the last increase is close to that amount. He also suggested implementing this over two years with 50% going into effect on July 1, 2019, and the remainder on July 1, 2020. Supervisor Cann and Long discussed the salary study, CPI, and what was meant by keeping salaries whole. Further discussion ensued regarding how to prevent salaries from falling behind in the future, creating a range for salaries, the lack of comparable data for certain of the positions, the reasoning behind Board member suggestions for

changes as well as reasons to follow the study's recommendations, changes to the item, the process to date including recent changes to the item, and language in the item noting the CPI since the last pay raise.

Supervisor Long moved the item as requested, except with a 15% increase for numbers 3, 4, and 8; and that the increase be spread over two years beginning with July 1, 2019 for the first year and July 1, 2020 for the second year, without compounding. Supervisor Jones seconded the item. Chair Menetrey called for the vote and the matter was defeated, 2-3, with Supervisors Cann, Menetrey, and Smallcombe opposed.

Supervisor Smallcombe then moved the item as presented, which Supervisor Cann seconded noting that he is still troubled that the Treasurer - Tax Collector is floating out there and that he would like that to be considered at some point separately. Board deliberation ensued. Chair Menetrey called for the vote. Supervisors Cann, Menetrey, and Smallcombe voted aye; Supervisors Jones and Long voted nay, however, the item requires a 4/5th vote so the motion fails.

Supervisor Long made the motion that the item be approved amended so that numbers 1, 2, 4, 6, and 7 be approved as proposed, that number 3 receive a 10% increase, and that number 5 approve a 15% increase. Supervisor Jones seconded the motion. Discussion ensued. Supervisor Jones called the question. Supervisors Cann, Long, and Jones voted aye; Supervisors Smallcombe and Menetrey voted nay. The result failed to meet the 4/5th vote threshold and so the motion fails.

Supervisor Cann observed that the Board is in concert on numbers 1, 2, 4, 6 and 7 and that it can take up separately numbers 3 and 5. Supervisor Menetrey agreed. Supervisor Smallcombe discussed with Ms. Williams whether the recommended salaries on page 667 address the cost of living increases that have occurred since the last comp study. Supervisor Cann moved the item as presented, with the caveat that the Board would be happy to deal with numbers 3 and 5. Supervisor Long seconded the motion. Supervisor Jones asked if the Board was willing to take up numbers 3 and 5 this evening. Chair Menetrey called the question. The motion failed 3-2 with Supervisors Smallcombe, Cann, and Menetrey voting aye, Supervisors Long and Jones voting nay.

Supervisor Jones noted that he voted nay because discussion was cut off, but inquired as to how long it will take HR to bring the item back for consideration. Kim Williams noted that it will not take long. Supervisor Jones inquired as to an exact timeframe and was told that the item can return by the second meeting in January.

Supervisor Cann moved the item as presented. Supervisor Smallcombe seconded. Supervisor Jones discussed the two position of concern and requested the motion be amended. Supervisor Smallcombe withdrew her second, and Supervisor Cann amended his motion to approve the study as presented to them, with the caveat that items 3 and 5 are approved as requested, but will be brought back the second meeting of January for further discussion with further information. Supervisor Smallcombe seconded the amended motion.

Receive a Presentation Regarding the Yosemite Renaissance Art Competition; and Accept a Gift of Art (Jon Bock, Yosemite Renaissance Director)

Jonathan Bock/Yosemite Renaissance Executive Director spoke of the program and some of the problems they have seen recently with natural disasters. He also provided handouts and a flyer and discussed the competition, the increase in applicants due to increased social networking, as well as some future plans. Mr. Bock also presented the Board with a framed photograph by David Hoffman and discussed the artist's background. No public comment. Board discussion ensued.

2. Administration RES-2019-731

Adopt a Resolution Approving Planning, Building, Environmental Health, Engineering / Surveyor, and Airport Operations Fee Adjustments Effective March 1, 2020

Dallin Kimble provided an overview of the history of the item, and introduced Leigh Westerlund/Assistant County Administrative Officer who gave the staff report with the assistance of NBS consultants, Tim Seifert and Kevin Gardner. In response to Supervisor Jones' inquiry, Ms. Westerlund noted that departments can do their increase on February 1st.

Public comment opened. Harry Steed, resident discussed the timing and transparency of the item and asked that the Board consider phasing the new fees in over several years. Jack Bankhead noted his belief that the increase in salaries has a lot to do with this action. David Butler urged against the action noting that he can't run his business with these fees; and requested that action be delayed for a few weeks. Ken Melton urged against the item noting that the hangar fees are now profit given that the hangars are paid off; remarked that the appeal fee is high enough to keep people from appealing; and noted that the things people are being required to do are not in the books, ordinance, etc. and that staff is spending a lot of unnecessary time for no purpose. Tony Borreson/Airborrn Aviation expressed his appreciation of the fee assessment noting that it has been a long time in coming, but expressed concern that airport tie downs went from \$31 to \$65 per month, and that hangars are going up \$55; and noted that he was also speaking on behalf of Skydive Yosemite who could not be here due to the birth of their daughter today. Mark Regal commented that Public Works charges \$135 an hour across the board in Portland, Oregon; advised that a 100% cost recovery is going to cause people to not want to comply; and requested that the Board reconsider these fees. Public comment closed.

Board discussion ensued. In response to Board questions, clarification was provided by Mike Healy, Mike Kinslow/Building Director, and Sarah Williams.

Supervisor Long moved to accept the fee study increases and decreases spread out over four years. Supervisor Cann seconded with a question of whether staff should be asked to come back with an analysis of effects. After discussing the matter, Supervisor Cann and Long withdrew the second and motion.

Further Board deliberation ensued regarding budgetary effects, the potential shock to building permits, and the effects of increases and decreases on the Building Department. Luis Mercado/Auditor noted that phased in fees is a good idea but that

decreases should be completely done at the beginning. Mike Kinslow requested that Building be considered separately because they are an Enterprise Fund. Supervisor Jones noted that he checked with County Counsel and that it is permissible to split the Building Department fees out today and bring the others back another time.

The Board unanimously approved the fees as to the Building Department only, and gave direction that fees for the remaining departments return adjusted per Board direction.

ACTION: Accept the Building Department's fees as presented; and bring back the remaining department fees with adjustments.

DIRECTION: For the other four departments: Fees that are being raised more than 25% are to be phased over a four year period, including CPI, on the fully burdened number; and reduce all fees that have been identified as lower than current fees. For the Planning Department: reduce the counter time included in the fully burdened hourly rate from 60% to 30%, and adjust the fully burdened hourly rate for Planning accordingly. For the Airport: the hangar fees will be increased to the 100% level but will not be applied to existing leases and, instead, will take effect only upon the execution of new leases.
