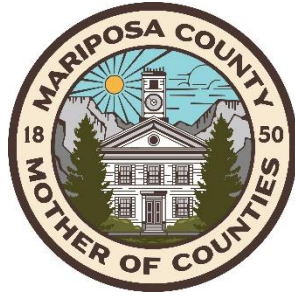

**The purpose and functions of the CPSAC shall be to:**

- a. Help design and implement activities like workshops and open houses to involve the community in establishing Mariposa County's Creative Placemaking Strategy;
- b. Provide insight into the kinds of placemaking projects, programs, and policies that can help achieve the General Plan's vision.
- c. Coordinate with staff and consultants to inventory existing local placemaking resources, identify areas of opportunity, and provide other content to make the Creative Placemaking Strategy effective; and
- d. Provide periodic feedback to the Board of Supervisors regarding the success of the Creative Placemaking Strategy.

**Membership terms are for 3 years, expiring the last day of February. One vacancy is to fill an unexpired term which ends February 28, 2025 the other is to fill an unexpired term which ends February 28, 2023, but if not filled until after February 28, 2023 the new expiration will be February 28, 2026.**

**Meetings of this committee are generally held on the 2<sup>nd</sup> Monday of the month at noon at Mariposa Government Center which is located at 5100 Bullion Street, Mariposa CA.**
