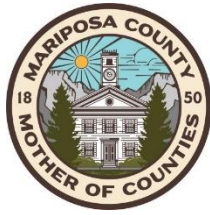

Enclosed you will find an invoice that accounts for all costs incurred by Mariposa County for debris removal from your parcel following the Oak Fire.

**If you DID NOT have insurance covering debris removal (for removal of structural, tree, or vehicle debris), this notification serves as information only. You are not required to do anything further.**

**If you DID have insurance covering debris removal (for removal of structural, tree, or vehicle debris), you are required to reimburse Mariposa County only the amount you were paid by the insurance company, not to exceed actual debris removal costs.** In the event the insurance proceeds are less than the cost of the debris removal, you are not responsible for the difference. If the insurance proceeds exceed the cost of debris removal, you may keep any excess proceeds. Please review your insurance policy settlement statement to determine the amount you need to reimburse the County for debris removal. Please provide these two items to Mariposa County at the address on the enclosed invoice:

1. A copy of your insurance policy settlement statement confirming the amount of covered debris removal cost paid to you
2. A check for the amount of the insurance proceeds you are reimbursing, payable to Mariposa County, with your Assessor's Parcel Number (APN) and Oak Fire written on the check

We realize this is an unwelcome task and a bitter reminder of the losses you have suffered. Your cooperation will help the County discharge its obligations to the State – a critical step in the County's ongoing recovery from this disaster. Thank you for your help with this difficult stage.
