### RECOMMENDATION AND JUSTIFICATION:

Review and Approve a style of street light and support pole for 17 poles/lights in Coulterville and 4 poles/lights in Mariposa.

PG&E has contacted the County concerning a program that they have to replace old street lights on wooden light poles with newer street lights on poles made of more durable materials. There is some urgency to providing direction to PG&E concerning the preferred style of the replacement lights and poles.

According to PG&E staff there are two types of lights and four types of poles to choose from that are eligible for this program. The Board needs to provide direction to staff concerning which styles are most acceptable. Once this direction is received staff will coordinate the installation of the poles and lights with PG&E. Installation is currently scheduled for late October of this year.

There is no cost to the County for this program.

There will be a PowerPoint presentation illustrating the styles and types of lights and poles. Additionally, examples of the styles will be made available by hard copy prior to the Board meeting.
