RECOMMENDED ACTION AND JUSTIFICATION:

Adopt a Resolution Authorizing the Submission of the Functional Classification Road Change Request Form and Attachments, and Approval of the Requested Road Reclassifications.

Staff recommends the reclassification of Silver Bar Road from Local to a Minor Collector and Whitlock Road from a Minor Collector to a Major Collector due to the high Average Daily Traffic (ADT) counts and the connectivity each provides to other major collectors and highways. These reclassification changes will also allow the County to receive Federal funding for improvements.

**WHEREAS**, this request is consistent with the approved classification system;



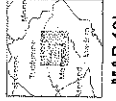
Silver Bar Road

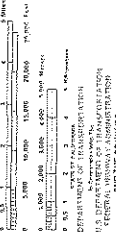
