RECOMMENDED ACTION AND JUSTIFICATION:

Approve the Events Occurring in the Mariposa Arts Park, the Mariposa Creek Parkway, 7th Street, 5th Street Parking Lot, Mariposa County Park/Amphitheater/Skate Park, Mariposa County Court House Lawn, History Center, and Mariposa County Fairgrounds, on April 30, May 1 and May 2, 2010, as Part of the Annual Mariposa's Butterfly Festival as a County Sponsored Event for Insurance Purposes, which includes use of the senior bus; Approve a Letter to CalTrans approving the Detour of Traffic from State Routes to Mariposa County roadways for the duration of the "Mariposa Butterfly Festival Parade", and Authorize the Board of Supervisors Chair to Sign a Letter to the Department of Transportation

By making this a County sponsored event it will be added to the County's liability insurance. There is no additional cost to the County for this, however if there is a claim then it is possible that the County's insurance premium may increase when it is renewed.



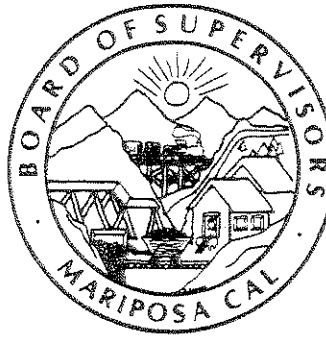
