RECOMMENDED ACTION AND JUSTIFICATION: Request approval to accept the highest reasonable bid for the sale of the 1985 Caterpillar 826C previously purchased by the Mariposa County Department of Public Works for the Mariposa County Landfill. The proceeds of the sale of this piece of equipment are to return to the Solid Waste & Recycling Division. This bid was received from National Hardware Supply for an amount of \$9,500 which includes picking up the compactor at the landfill at their expense.

The local Solid Waste Association of North America chapter and the Environmental Services Joint Powers Authority members were notified that Mariposa County Public Works Solid Waste & Recycling Division was interested in selling the 1985 Caterpillar 826C. In addition two scrap metal recyclers provided bids on what they would be willing to pay for the equipment. These bids were from EO Truck for \$6,000.00 and from Marc Silva for \$4,500.

The revenue from the sale of the 1985 Compactor will go toward assisting in maintaining the level of solid waste and recycling service currently provided to Mariposa County residents.

BACKGROUND AND HISTORY OF BOARD ACTIONS: In March the Board of Supervisors approved the sale of the 1985 Caterpillar 826. This agenda item is to approve acceptance of the highest reasonable bid.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION: If the Board of Supervisors does not approve acceptance of the highest reasonable bid for the 1985 Compactor the value of the compactor will continue to decline.
