Resolution authorizing the Chairman of the Board of Supervisors to approve Budget Action Accepting Unanticipated Revenues of (\$3675) due to unanticipated increase in pesticide mill assessment subvention for FY 2007/08

(4/5ths vote)

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The California Department of Pesticide Regulation annually subvents Mariposa County's portion of the Pesticide Mill Assessment collections in accordance with Section 12844 of the Food and Agricultural Code to support the county pesticide use enforcement program. There was an unanticipated increase in the FY 2007/08 subvention amount and the budget action accepts unanticipated revenue in the amount of \$3675 to purchase equipment, supplies, and accessories to be used for the pesticide use enforcement program.

Approving this budget action will provide funding from the pesticide mill assessment subvention for the purchase of equipment for the Mariposa County pesticide use enforcement program.
