Recommendation

It is respectfully recommended that your Board authorize: (1) a continuing contract for FY 2008-2009 between the County of Mariposa and Value Options (VO) for administration of Mental Health counseling for foster children placed out of county; and (2) authorize your Chairman to sign the contract.

Background/Current Situation

Mariposa County has contracted with Value Options (VO) since March 2004 for mental health medical specialty services for full scope Medi-Cal beneficiaries under the age of 18 placed outside of Mariposa County. The current contract was approved by your Board on May 22, 2007 by Resolution No. 07-217. Ten (10) children have been served during the fiscal year ending June 30, 2008.

Financial

The cost of \$44.93 per month per eligible beneficiary is included in the current FY budget. The cost of the individual service units are reimbursed through the Medi-Cal Program. No County general funds are required.
