### Recommendation

It is respectfully recommended that your Board: (1) authorize the department to accept a continuing, although late, grant agreement for FY 2006-2007 between the Mariposa County Friday Night Live Partnership and the Tulare Superintendent of Schools for The Friday Night Live Mentoring Program for compliance with the "No Child Left Behind Act", Title IV-21st Century Schools and all applicable regulations and federal guidelines; and (2) authorize the Human Services Director to sign the agreement.

# **Background / Current Situation**

Mariposa County has, for five years, contracted with Tulare County Office of Education and the California Friday Night Live Partnership for implementation of the Friday Night Live Mentoring (FNLM) Program. This program recruits. screens and trains high school mentors who are then matched with middle school protégés. Through sixteen supervised sessions, the mentors help the protégés develop character building skills and make healthy decisions about alcohol, tobacco and other drugs. The program helps middle school students transition to high school.

# **Financial**

This contract brings in \$33,500 to the Alcohol and Drug prevention budget. This money has been budgeted for fiscal year 2006/2007 as line item 001-0403-305.51-56. There is no local match requirement.
