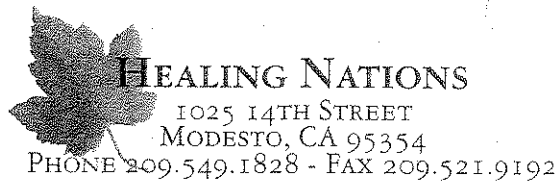

Dear Ms. Benson,

Healing Nations' second annual Covered Bridge Bike Classic is slated for September 22, 2007. Last year our ride was within Stanislaus and Merced counties only, but this year we will be in Mariposa and Tuolumne counties as well.

This is a ride and not a race. There will not be any road closures. Riders will begin in Snelling at 6:00 AM or shortly there after and should be out of Mariposa County by 12:00 Noon at the latest.

Bicyclists will enter Mariposa County just northeast of Merced Falls on Merced Falls Road. They will travel to Banderilla Drive and turn left onto Banderilla Drive. At Hidalgo Street they turn left and travel to Highway 132 where they will turn right. They will exit out of Mariposa County on Highway 132. We will be fully co-operating with CHP and CalTrans at Highway 132.

Healing Nations will be securing insurance for this event and will most certainly add Mariposa County as an additional insured.

I am very hopeful that the Mariposa County Board of Supervisors will waive the encroachment fee as others counties have done for us in the past. We are a non-profit trying to generate as much money as we can to assist disadvantaged children.

Healing Nations is a 501 (c) (3) non-profit. Our tax ID number is 77 0550481. We serve at-risk children and youth in west Modesto. All proceeds earned from this fundraiser will benefit needy children.

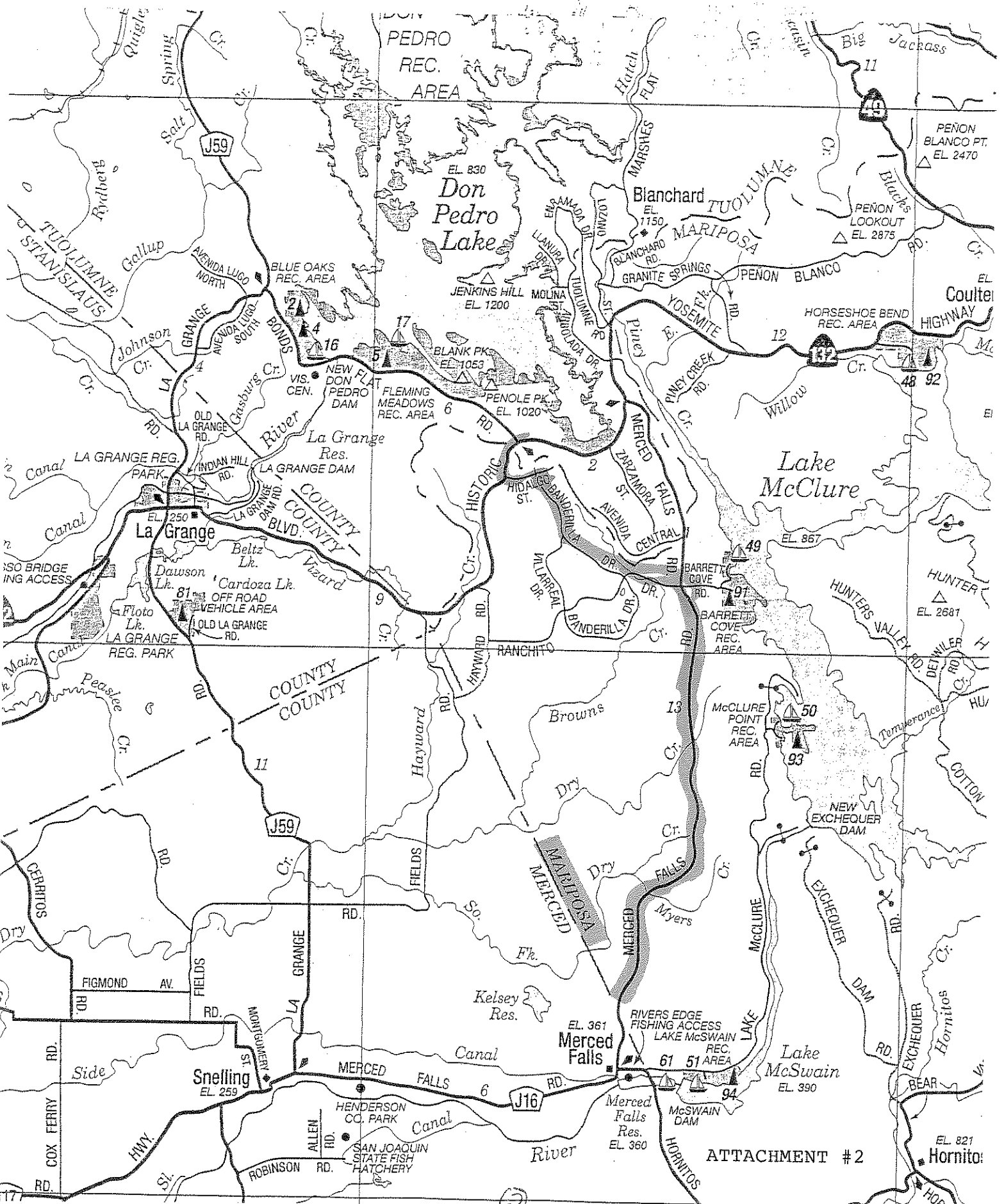
I look forward to hearing from you as to what your protocol is for an event such as this. Please let me know as soon as possible what I can do to receive your approval.
