RECOMMENDED ACTION AND JUSTIFICATION: Resolution authorizing acceptance of grant funding from The United States Department of Home Land Security and The State of California Office of Home Land Security to identify critical infrastructure sites in California. The New Exchequer Dam is one of those sites identified as critical infrastructure. Total grant funds to be received by The County of Mariposa is One Hundred Eighty-nine Thousand Dollars (\$189,000).

The United States Department of Home Land Security has set aside funds for The State of California Office of Home Land Security to identify critical infrastructure sites in California. The New Exchequer Dam was one of those sites identified as critical infrastructure.

The United States Department of Home Land Security has issued grant funds under Grant Number 2006-BZ-T6-0045 to The State of California Office of Home Land Security (OES) ID # 043-00000 to the Mariposa County totaling One Hundred Eighty-Nine Thousand Dollars (\$189,000) for purchase of equipment to be used in the protection of the New Exchequer Dam.

The grant funding is for a one time purchase of equipment. The funds must be expended by June 30, 2007. The equipment to be purchased has been approved by The State of California Office of Home Land Security. The County of Mariposa will be fully reimbursed for the items purchased.

BACKGROUND AND HISTORY OF BOARD ACTIONS: Mariposa County has participated in other grants from the United States Department of Home Land Security and the State of California Office of Home Land Security.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION: The County of Mariposa would have to provide 100% of the cost to provide security to sites identified as critical infrastructure.


