RECOMMENDED ACTION AND JUSTIFICATION:

Approve Budget Action to re-allocate funds donated by TDS Telecom in the amount of \$1,500 for the purchase of an Automated External Defibrillator (AED) for the Hornitos community. Mariposa County Fire Department will soon have three new EMS responders who live in the Hornitos community. Since we do not have a response station, these new members will respond from their homes as members of Company 23, Catheys Valley and under the supervision of Captain Richard Shelton. This marks the advent of a restored level of service for the community not experienced for over three decades. An integral tool in a rural medical responder's kit is an AED to aid in sudden cardiac arrest cases. TDS Telecom (Hornitos Telephone) has granted \$1,500 to supply that tool to our responders.

The AED will be compatible with Mariposa's Public Access Defibrillation (PAD) program and be administered under the supervision of Dr. Charles Mosher and training provided by certified Mariposa County Fire Department instructors.
