Authorize Chairman to sign Interagency Agreement between the 35-A District Agricultural Association and Probation Department to allow use of the shooting range by members of the Mariposa County Probation Department. The contract will allow members of the Probation Department to use the shooting range without the need to coordinate with other agencies. The Mariposa County Sheriff Dept. and Mariposa CHP have similar Contracts.

# INTERAGENCY AGREEMENT

THIS AGREEMENT is entered into this 1st day of June, ~~19~~ 2002




**TERMS OF THE AGREEMENT:**

1. The Department of Food and Agriculture, Division of Fairs and Expositions, 35-A District Agricultural Association, hereinafter called ASSOCIATION agrees to authorize rental of weapons firing range to the Mariposa County Probation Department, hereinafter called PROBATION, subject to the following provisions:
2. The use of said range by PROBATION shall be limited to those members of the Mariposa County Probation Department.
3. PROBATION agrees that such use is for official departmental training and qualification and range will not be used for personal use of any kind.
4. ASSOCIATION and PROBATION agree that shooting range shall be open and usable by members of the Mariposa County Probation Department at such times that are mutually agreeable to both parties hereto, but that exclusive use of the facilities for any time or times is not granted without mutual agreement of both parties.
5. Either party hereto may terminate this agreement by giving written notice to the other party at least thirty (30) days prior to the effective date of such termination.
6. Amendments shall be valid only if made in writing and signed by both parties hereto.
7. PROBATION agrees to abide by established and accepted safety rules while exercising the privileges of this agreement.
