RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes____ No(_X_)

Authorize the Public Works Director to contract with Pacific Gas and Electric Company in the amount of \$64,589.66 to relocate the power lines at the Mariposa County Landfill.

Two power lines must be moved. One line is located directly over the active landfill module, which we have been prohibited from using until the line is moved; and the second line runs directly over the site of the proposed co-compost facility. Please refer to Attachment #1, "Summary of Payments" which lists the cost breakdown for a total cost of \$64,589.66. Funding for this work has been included in the requested FY 2002-2003 Solid Waste Budget, Professional Services, Number 601-0404-651-0418.

The Solid Waste Committee reviewed and supports the relocation of both power lines and is aware of the urgency to complete this work due to both safety issues of power lines in proximity to the current filling location (Attachment #2) and lack of other viable locations to place trash that conform to the planned fill sequence design. An alternate fill location on Module 2 has been identified and should hold a few weeks of trash while this work is completed.

On August 14, 2002 the Board Chairman sent a letter of intent to Pacific Gas and Electric Company notifying them of this urgent work that needs to be completed (Attachment #3).

BACKGROUND AND HISTORY OF BOARD ACTIONS:

This item was brought before the Board on August 6th requesting authorization to complete the work using funds from the Compost Facility Budget and the Solid Waste Professional Services Budget. The Board again reviewed this item at its August 13th meeting and authorized the letter from the Board Chairman to Pacific Gas and Electric Company dated August 14, 2002 (Attachment #3).
