RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No X)

Approve Plans and Specifications and

Authorize the Public Works Director to advertise and award bid for **Mariposa Town Sidewalks Adjacent to State Highways and County Roads**, Project Number 95-42. This is for sidewalk construction at the following locations:

West side of Highway 140 from the YARTS Bus Stop at 7th Street to 10th Street

South side of 10th Street from Highway 140 to Jessie Street

West side of Jessie from 10th to 13th Streets

West side of Highway 140 from 13th Street to Highway 49 North, and

Highway 49 North from Highway 140 to the Yosemite Bank/Miner's Inn driveway.

Regional Transportation Improvement Program (RTIP) funding (\$650,000) was allocated for this project February 28, 2002, and was carried over in the 2002-03 budget.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board adopted a resolution executing agreements for STIP funds for right of way, design and construction of the Mariposa Town highway sidewalks on July 27, 1999, and executed an agreement with Roger Stephens on November 2, 1999, and October 2, 2001, for the design work. On January 22, 2002, the Board viewed the design and discussed a proposed delegated maintenance agreement.

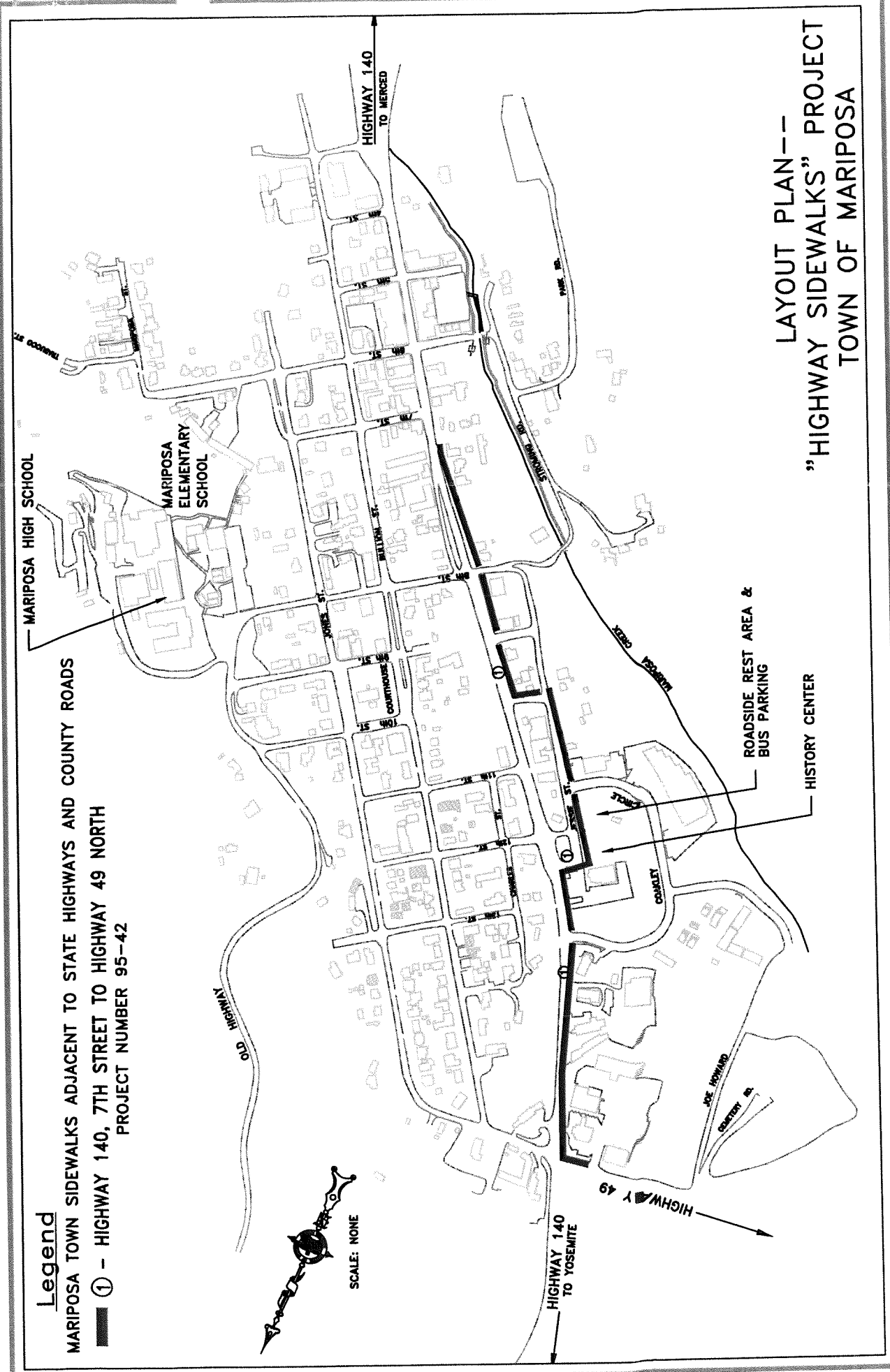
