

MARIPOSA COUNTY RESOLUTION NUMBER 99- 215

A RESOLUTION RECOGNIZING CHARLOTTE WILSON FOR HER SERVICE TO THE COUNTY OF MARIPOSA

WHEREAS, CHARLOTTE "CHAR" WILSON has devoted countless hours serving the Community as a dedicated County employee since 1980; and

WHEREAS, during this time CHAR served in several progressively more responsible positions including Energy Program Administrator; Office of Economic Opportunity/Department of Energy Programs Coordinator; Community Services Contracts Administrator; Housing and Community Development Contracts Administrator; and Contract Administrator for the Calaveras-Mariposa Community Action Agency; and

WHEREAS, during this time CHAR was responsible for developing and implementing many department programs and services of benefit to the community including energy assistance; low income housing weatherization; Emergency shelter care for homeless and disaster victims; FEMA funds for emergency food and shelter needs; CDBG grants for Native American housing rehabilitation; and performance monitoring and reporting on many other programs serving the communities throughout Calaveras and Mariposa Counties; and

WHEREAS, CHAR received numerous commendations over the years from Federal and State program evaluators, community members, agency heads and elected officials for the quality of her work in all areas including fiscal record keeping and reporting; grant writing and development; program supervision; and interpersonal relations; and


WHEREAS, CHAR set a personal standard of excellence, providing inspiration to her colleagues for her commitment to public service and increased her own value in County service by returning to school during this period earning a Bachelor of Arts Degree in Sociology from California State University Stanislaus, and completing substantial work toward a Masters Degree in Rural Sociology from that same institution; and


WHEREAS, CHAR made many additional contributions to the County and Department of Human Services including representing the department director in numerous forums important to maintaining the integrity of programs and ensuring an equitable allocation of State and Federal resources to Mariposa County and other rural areas; and


