ADOPT RESOLUTION APPOINTING CHIEF PROBATION OFFICER PETE JUDY, CHAIRPERSON OF THE JUVENILE JUSTICE COORDINATING COUNCIL (JJJC). ACCEPT MEMBERSHIP OF COUNCIL AS RECOMMENDED. AUTHORIZE PETE JUDY TO SIGN THE APPLICATION FOR APPROVAL FOR SCHIFF-CARDENAS CRIME PREVENTION ACT OF 2000 FUNDING AS WELL AS RELATED CONTRACTS, AMENDMENTS, OR EXTENSIONS WITH THE STATE OF CALIFORNIA.

AB1913, THE SCHIFF-CARDENAS CRIME PREVENTION ACT OF 2000, RELEASED STATE FUNDS TO MARIPOSA COUNTY IN THE AMOUNT OF \$57,053. THE FUNDS MUST BE USED FOR JUVENILE CRIME PREVENTION AND INTERVENTION PROGRAMS THAT HAVE BEEN PROVEN TO BE SUCCESSFUL. THE FUNDED PROGRAM (S) MUST ADDRESS A GAP (S) IN SERVICES IDENTIFIED IN THE LOCAL ACTION PLAN. THE PLAN AND PROPOSED PROGRAM (S) MUST BE SUBMITTED TO THE BOARD OF CORRECTIONS FOR FINAL FUNDING APPROVAL.

FUNDS MUST BE USED BY JUNE 30, 2002 OR THEY REVERT BACK TO THE STATE'S GENERAL FUND.
