MARIPOSA COUNTY ORDINANCE NO. 971

**AN ORDINANCE AMENDING SECTION 2.44.020 ENTITLED "MEMBERSHIP"
TO CHAPTER 2.44 ENTITLED "BOARD OF LAW LIBRARY TRUSTEES" OF THE
MARIPOSA COUNTY CODE**

The Board of Supervisors of the County of Mariposa does ordain as follows:

SECTION I: Section 2.44.020 of Chapter 2.44 of the Mariposa County Code is hereby amended to read as follows:

2.44.020 Membership.


The Mariposa County Board of Law Library Trustees is constituted as follows:

- A. Both Judges of the Superior Court are to serve as ex officio trustees;
- B. The Chair of the Board of Supervisors is an ex officio trustee, but the Board of Supervisors at the request of the Chair may appoint a member of the State Bar, any other member of the Board of Supervisors, or a resident of the county to serve as trustee in place of the Chair;
- C. The District Attorney;
- D. County Counsel; and
- E. President of the Local Bar Association

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to the provisions of Government Code Section 25123.




