RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes X No)

Public Works recommends that the Board adopt an Ordinance making Upper Bullion Street (County Road 87X) one way between 8th and 9th Streets. Traffic would travel in the southerly direction.

Lower Bullion Street would remain two way. The proposed one-way street is that section that lies on the south (upper) side of the planter strip and provides access to the Villa Monte Bed and Breakfast, the offices of Roger Stephens Engineering, Inc. and the offices of the Mariposa Title Co. This street is narrow, and the proposed one-way direction is for safety purposes. The majority of owners along this street are in favor of making it one way in the direction proposed.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Section 10.08.120 of the Mariposa County Code of Ordinances provides for one-way streets and this ordinance would amend the Code section to include Upper Bullion between 8th and 9th as proposed.

MARIPOSA COUNTY ORDINANCE No. 916

**AN ORDINANCE AMENDING SECTION 10.08.120
ENTITLED "ONE-WAY STREET"
OF CHAPTER 10.08 ENTITLED "STOPPING, STANDING AND PARKING"
OF TITLE 10 "VEHICLES AND TRAFFIC"**

WHEREAS, the Board of Supervisors desires to create an improved traffic circulation pattern and enhance the public safety on Upper Bullion Street (County Road 87X) by changing the portion between Eighth Street and Ninth Street, from two-way traffic to one-way traffic only;

NOW THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:


SECTION I: Section 10.08.120 entitled "One-Way Street" of Chapter 10.08 entitled "Stopping, Standing and Parking" shall be amended by adding the following Paragraph C of Section 10.08.120 to the Mariposa County Code of Ordinances:

"Upper Bullion Street from Ninth Street to Eighth Street in the township of Mariposa shall be a one-way street with traffic allowed to travel in a Southerly direction only."

SECTION II: This Ordinance shall become effective thirty (30) days from the date of final passage, pursuant to California Government Code Section 25123.

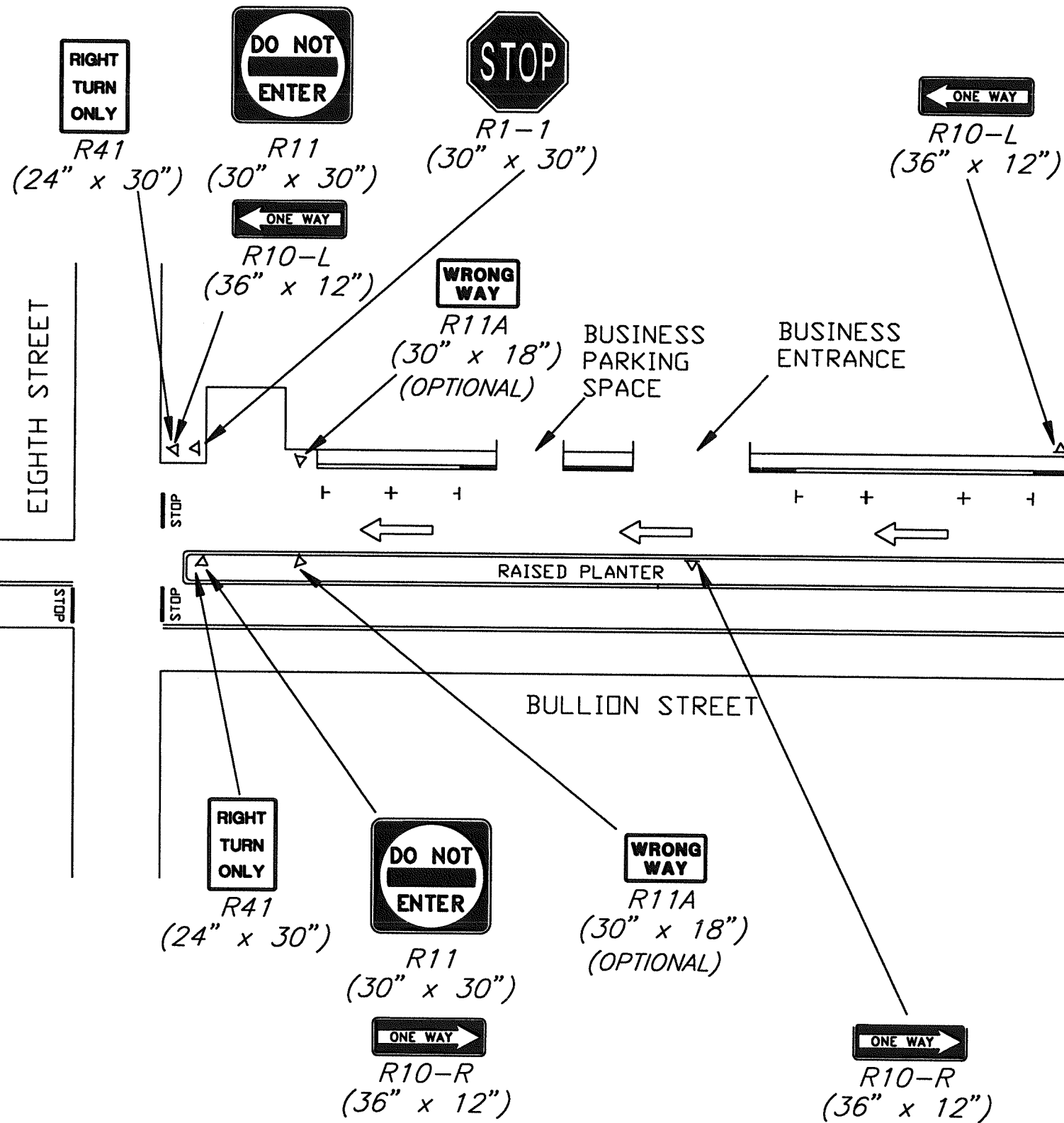

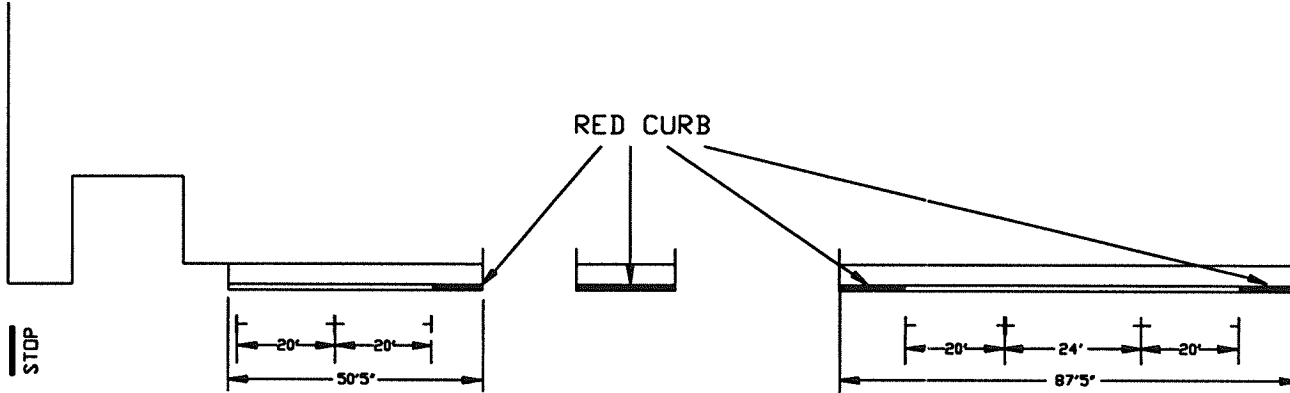
