

MARIPOSA COUNTY ORDINANCE NO. 810

AN ORDINANCE AMENDING SUBSECTION "F"
OF SECTION 6.08.010 ENTITLED "DEFINITIONS"
AND ADDING SUBSECTION "F" TO SECTION 6.08.110
ENTITLED "IMPOUNDMENT--DISPOSITION OF ANIMALS"

WHEREAS, Chapter 6.08 of the Mariposa County Code is enforced by the Small Animal Control Officer and does not address the issue of large livestock relative to enforcement of this Chapter, and

WHEREAS, the Mariposa County Board of Supervisors has concurred with a recent request by the Constable to establish fees for the transportation and board and care of large livestock and the tranquilizing of small animals and large livestock , and

WHEREAS, the enforcement of these fees will aid in subsidizing Mariposa County for costs incurred such as salaries and equipment costs;

NOW THEREFORE, the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does ordain as follows:

SECTION I: Section 6.08.010 entitled "Definitions" of Chapter 6.08 entitled "Animal Control" shall be amended to read in its entirety as follows:

F. "Small Animal Control Officer" is the designated person to enforce this chapter relative to animals other than large livestock. The Mariposa County Constable is the designated person to enforce this chapter relative to large livestock.


SECTION II.: Subsection "F" shall be added to Section 6.08.110 entitled "Impoundment--Disposition of Animals" to Chapter 6.08 entitled "Animal Control" to read in its entirety as follows:

F. When large livestock are to be transported, the animal control officer shall charge a transporting fee of \$35.00 per load plus .50 per mile. Any large livestock that are impounded the owner thereof shall incur a fee of \$6.00 per day for board and care. If the animal control officer deems it necessary to tranquilize a small animal, a tranquilizing fee of \$30.00 shall be charged. If the animal control officer deems it necessary to tranquilize a large animal, a tranquilizing fee of \$50.00 shall be charged.

SECTION III.: This ordinance shall become effective thirty (30) days from date of final adoption pursuant to California Government Code Section 25123.


