MARIPOSA COUNTY ORDINANCE NO. 755

AN ORDINANCE DECLARING THE NEED
FOR A REDEVELOPMENT AGENCY
TO FUNCTION IN THE COUNTY OF MARIPOSA AND
DECLARING THE BOARD OF SUPERVISORS TO BE
THE REDEVELOPMENT AGENCY
BY ADDING CHAPTER 3.48 ENTITLED
"REDEVELOPMENT AGENCY OF MARIPOSA COUNTY"
TO TITLE 3 OF THE MARIPOSA COUNTY CODE
ENTITLED "REVENUE AND FINANCE"

WHEREAS, the California Community Redevelopment Law (Health and Safety Code Section 3300 \underline{et} \underline{seq} .) in Section 33100 creates in the County of Mariposa a public body, corporate and politic, known as the redevelopment agency, for the purposes of exercising the powers granted by the Community Redevelopment Law; and

WHEREAS, Section 33101 of the Community Redevelopment Law provides that said redevelopment agency shall not transact any business or exercise any powers unless, by ordinance, the Board of Supervisors (the "Board") of the County of Mariposa declares that there is a need for such a public body to function; and

WHEREAS, Section 33200 of the Community Redevelopment Law provides that as an alternative to the appointment of five (5) members of the redevelopment agency, the Board may declare itself to be said agency, in which case all rights, powers, duties, privileges and immunities of the redevelopment agency shall be vested in the Board;

NOW THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF MARIPOSA DOES ORDAIN AS FOLLOWS:

<u>SECTION</u> <u>I</u>: Chapter 3.48 entitled "Redevelopment Agency of Mariposa County" is hereby added to Title 3 of the Mariposa County Code entitled "Revenue and Finance" and shall read in its entirety as follows:

"Chapter 3.48

REDEVELOPMENT AGENCY OF THE COUNTY OF MARIPOSA

Sections:

- 3.48.010 Purpose.
- 3.48.020 Creation.
- 3.48.030 Board of Supervisors acts as Agency.

3.48.010 Purpose.

It is hereby found, determined and declared that there is a need for a redevelopment agency to function in the County of Mariposa in accordance with the provisions of the Community Redevelopment Law.

3.48.020 Creation.

A redevelopment agency is hereby established pursuant to Section 33101 of the Community Redevelopment Law, to be know as the Redevelopment Agency of the County of Mariposa (the "Agency"). The agency is hereby authorized to transact business and exercise its powers under provisions of the Community Redevelopment Law.

3.48.030 Board of Supervisors acts as Agency.

The Board hereby finds and determines that the designation of the Board as the Agency will serve the public interest and promote the public safety and welfare in an effective manner in that this public body is best able to serve the needs of the community to implement the purposes of the Community redevelopment Law. Pursuant to the provisions of Section 33200 of the Community Redevelopment Law, this Board hereby declares itself to be the Agency.

SECTION II: The Clerk of the Board is hereby directed to cause a certified copy of this ordinance to be filed in the office of the Secretary of State.

SECTION III: The Clerk of the Board is hereby directed to certify to the passage of this ordinance and to cause the same to be publised once in the Mariposa Gazette and Miner, a newspaper of general circulation, published and circulated in the County of Mariposa, California.

This ordinance shall become effective thirty (30) days after its final passage and adoption pursuant to California Government Code Section 25123.
