

MARIPOSA COUNTY ORDINANCE NO. 670

REPEALING ORDINANCE NO. 553, AND  
AMENDING CHAPTER 2.08 ENTITLED "CONSOLIDATION OF OFFICES"  
BY ADDING SECTION 2.08.030 ENTITLED  
"THE CLERK OF THE BOARD OF SUPERVISORS"

WHEREAS, Government Code Section 25100.5 permits the County Board of Supervisors to create the office of the Clerk of the Board of Supervisors, and

WHEREAS, the Clerk of the Board, although employed through the County Clerk's office, actually works for the Board of Supervisors, and

WHEREAS, the Board of Supervisors has determined that it is in the public interest to create the office of the Clerk of the Board of Supervisors,

NOW THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: Ordinance No. 553, passed and adopted August 12, 1980, which deleted the Office of Clerk of the Board of Supervisors and appointed the County Clerk as the Ex Officio Clerk of the Board of Supervisors, is hereby repealed in its entirety.

SECTION II: There shall be added to the Mariposa County Code Section 2.08.030 entitled, "The Clerk of the Board of Supervisors".

"2.08.030 The Clerk of the Board of Supervisors. The office of the Clerk of the Board of Supervisors is hereby established. The Clerk of the Board of Supervisors shall be appointed by the Board of Supervisors of the County of Mariposa pursuant to Government Code Section 25100.5, in the same manner as other County officers are appointed. Notwithstanding anything to the contrary herein, the position of the Clerk of the Board shall be a permanent employee of the County and the Office of the Clerk of the Board shall not constitute a separate department. Upon the effective date of this ordinance, the County Clerk shall no longer serve as the Ex Officio Clerk of the Board Supervisors. The Clerk of the Board of Supervisors shall perform those duties prescribed by law for the County Clerk as Ex Officio Clerk of the Board of Supervisors or for the Clerk of the Board of Supervisors, together with such additional duties as the Board of Supervisors shall prescribe from time to time by ordinance, including but not limited to supervision of clerical staff under the direction of the Board of Supervisors. The Clerk of the Board of Supervisors may perform all of the duties vested in the MARIPOSA

Clerk of the Board of Supervisors

County Clerk excepting those duties vested in the County Clerk as Ex Officio Clerk of the Superior Court, Registrar of Voters and Commissioner of Marriages, and the Clerk of the Board of Supervisors may take acknowledgements and administer and certify oaths in the performance of the Clerk of the Board of Supervisors official duties. The Clerk of the Board of Supervisors shall have the authority to appoint an individual to serve on his or her behalf and to perform his or her duties in the absence of the Clerk of the Board of Supervisors."


SECTION III: This ordinance shall become effective thirty (30) days from the date of final passage, pursuant to Government Code Section 25123.
