3	AMENDING TITLE I OF THE MARIPOSA COUNTY CODE BY ADDING CHAPTER 1.30 ENTITLED "DIVERSION OF MISDEMEANOR OFFENDERS"
5	WHEREAS, California Penal Code Sections 1001.50 through 1001.55 provides for a program wherein first-time misdemeanor offenders
7	may be diverted from the penal system, and
8	WHEREAS, in order for the County of Mariposa to parti-
9	cipate in the diversion of misdemeanor offenders, an ordinance
10	must be adopted by the Board of Supervisors permitting the insti-
11	tution of such a program, and
12	WHEREAS, the Board of Supervisors of Mariposa County
13	finds it to be in the best interest of the citizens of Mariposa
14	County to divert selected first-time misdemeanor offenders out
15	of the penal system;
16	NOW, THEREFORE, The Board of Supervisors does hereby
17	ordain as follows:
18	SECTION I: Chapter 1.30 of Title I of the Mariposa County
19	Code is added to read in its entirety as follows:

27	The board of supervisors hereby adopts by reference
28	the provisions of Chapter 2.9, commencing with Sections

1001.50 through and including Section 1001.55 of Title 6, of Part 2, of the Penal Code of the State of California, together 2 with future revision thereof, regarding the diversion of 3 selected misdemeanor offenders." 4 5 SECTION II: This Ordinance has been deemed an urgency ordinance 6 by the Judges of the Superior and Justice Courts and the District 7 Attorney of the County of Mariposa as there are various mis-8 demeanor offenders presently in the penal system of the County of Mariposa that should be processed through the diversionary 9 10 program immediately thereby serving the best interests of the citizens of the County of Mariposa.
