

MARIPOSA COUNTY ORDINANCE NO. 648

AN ORDINANCE AMENDING
CHAPTER 2.04, ENTITLED
MEETINGS OF BOARD OF SUPERVISORS,
RELATIVE TO THE BOARD'S CAPACITY
AS BOARD OF DIRECTORS OF
DISTRICTS AND/OR AGENCIES

WHEREAS, the Board of Supervisors functions in the capacity of Board of Directors for many districts and/or agencies within the County, and

WHEREAS, it is necessary for the Board of Supervisors to adjourn as the Board of Supervisors and reconvene as a specific Board of Directors in order to carry on County business for that specific district and/or agency, and

WHEREAS, the Board of Supervisors desires to notice the public that all positions delineated as functions of the Board of Supervisors shall be in full force during each and every Board meeting, thereby precluding any need for adjournment as the Board of Supervisors and reconvening as a Board of Directors;

NOW THEREFORE, the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does ordain as follows:

SECTION I: Chapter 2.04, entitled MEETINGS OF BOARD OF SUPERVISORS, shall be deleted in its entirety and amended to read in its entirety as follows:

"Chapter 2.04

MEETINGS OF BOARD OF SUPERVISORS

Sections:

2.04.010 Regular meeting time and place.

1 2.04.020 Cancelling or rescheduling of meetings.

2 2.04.010 Regular meeting time and place. Regular meet-
3 ings of the board of supervisors shall be held at the Mariposa
4 County Courthouse in the town of Mariposa on the first four
5 Tuesdays of each month at nine a.m. for the transaction of any
6 and all business which may come before the board, both as a
7 board of supervisors and as the board of directors of the
8 following districts and/or agencies:

- 9 1. county Service Area 1M (Don Pedro Subdivision), and
- 10 a. Mariposa Pines Sewer Zone
- 11 b. Sewer Zone (Don Pedro Subdivision)
- 12 c. Coulterville Sewer and Water Zone.
- 13 2. Mariposa Parking District
- 14 3. Wawona County Services Area 2W
- 15 4. Hornitos Lighting District
- 16 5. Mariposa Lighting District
- 17 6. Coulterville Lighting District
- 18 7. Mariposa County Air Pollution Control District
- 19 8. Yosemite West Maintenance District
- 20 9. Mariposa County Water Agency

21 In the event any Tuesday should be a legal holiday,
22 the regular meeting of the board, both as a board of supervisors
23 and as the board of directors of the above districts and/or
24 agencies, shall be held at 9 a.m. at the above-mentioned place
25 on the next succeeding day which is not a legal holiday. In
26 the event any Tuesday should be a County-wide election day,
27 then and in such event, the regular meeting of the board, both
28 as a board of supervisors and as the board of directors of the


1 above districts and/or agencies, shall be held at 9 a.m. at the
2 above-mentioned place on the next succeeding Tuesday.

3 2.04.020 Cancellling or rescheduling of meetings. Not-
4 withstanding anything to the contrary contained in Section
5 2.04.010 above, the board of supervisors may, by majority
6 vote, cancel or reschedule any regular meeting of the board,
7 both as board of supervisors and as a board of directors of
8 the above districts and/or agencies. Any cancellation or
9 rescheduling of a regular board meeting shall be conducted
10 in open session at a regular meeting of the board."


11 SECTION II: This Ordinance shall become effective thirty (30)
12 days from the date of final passage, pursuant to Government
13 Code Section 25123.
