

MARIPOSA COUNTY ORDINANCE NO. 548

AN INTERIM ORDINANCE AMENDING ORDINANCE NO. 484 AND ORDINANCE NO. 501 FOR ONE YEAR TO CHANGE USER CHARGES FROM A MONTHLY BASIS TO AN ANNUAL BASIS FOR THE COULTERVILLE COUNTY SERVICE AREA NO. 1.

WHEREAS the provisions of Ordinance No. 484 Article II, Section 15, Subsection II: 1501 have caused hardship on the residents of Coulterville County Service Area No. 1 by imposing additional charges for water used each month above 12,400 gallons per connection irrespective of seasonal variations in water needs; and

WHEREAS the present capacity of the water system of Coulterville County Service Area No. 1 appears adequate to provide for seasonal variations in water consumption so long as total annual capacity is not exceeded;

NOW THEREFORE the Board of Supervisors of the County of Mariposa does hereby ordain as follows:

SECTION I: Article II, Section 15, Subsection II: 1501 of Ordinance No. 484, and the first paragraph of Section II of Ordinance No. 501 amending same, are hereby amended to read as follows:

"SECTION 15: WATER RATES

11:1501. User Charges. User charges for water service are ~~\$8.52~~ per month per connection for the first 12,400 gallons used and 80 cents per 1,000 gallons after the 12,400 gallons per month. Charge for new connection to the water system is \$926.67 per connection. Provided, however, and notwithstanding the above established rates, for the fiscal year beginning July 1, 1980 and ending June 30, 1981 only, user charges for water service shall be \$8.52 per month and 80 cents per 1,000 gallons after the first 150,000 gallons used for the one year period between July 1 and the following June 30; charges for water use in excess of 150,000 gallons for the period specified shall be billed at the end of the fiscal year in which they are incurred."

SECTION II: This ordinance shall take effect 30 days after the date of passage pursuant to Government Code Section 25123, and shall be effective until June 30, 1981, at which time it shall cease to be of any force or effect unless extended by ordinance.
