

1 MARIPOSA COUNTY ORDINANCE No. 594

2 COUNTY HOLIDAYS MODIFIED

3 WHEREAS, the Legislature of the State of California having
4 amended Government Code Section 6700 and Code of Civil Procedure
5 Sections 10, 12a, 134 and 135 to change the status of January 15,
6 "Dr. Martin Luther King, Jr. Day"; and

7 WHEREAS the Board of Supervisors having met and conferred
8 with authorized representatives of employee organizations;

9 NOW THEREFORE, the Board of Supervisors of Mariposa County
10 does hereby ordain as follows:

11 SECTION I: Section 2.64.020 of the Mariposa County Code is
12 hereby amended to read in its entirety as follows:

13 "2.64.020 Legal holidays. The following are estab-
14 lished as legal holidays in the county, pursuant to Govern-
15 ment Code Sections 6700, 18025, and 18025.1:

- 16 A. Every Sunday;
- 17 B. January 1st;
- 18 C. February 12th, known as Lincoln Day;
- 19 D. Third Monday in February;
- 20 E. Last Monday in May;
- 21 F. July 4th;
- 22 G. First Monday in September;
- 23 H. September 9th, known as Admission Day;
- 24 I. Second Monday in October, known as Columbus Day;
- 25 J. November 11th, known as Veterans Day;
- 26 K. December 25th;
- 27 L. Every employee shall be entitled to one personal

28 holiday per calendar year pursuant to Government Code Section

1 18025.1;

2 M. Every day appointed by the President or Governor
3 for a public fast, thanksgiving, or holiday, provided each
4 such day is specified as a paid holiday by the President or
5 Governor for public employees. The Thursday in November
6 appointed as Thanksgiving Day shall be a legal holiday in
7 Mariposa County;

8 N. Every employee shall be entitled to take as a
9 holiday the Friday preceding any Saturday on which one of
10 the holidays set out in subsections B, C, F, H, J and K
11 above occurs;

12 O. Every employee shall be entitled to take as a
13 holiday the Monday following any Sunday on which one of the
14 holidays set out in subsections B, C, F, H, J and K above
15 occurs;

16 P. Every employee shall be entitled to take one of
17 the following additional holidays, subject to the employee's
18 choice and prior approval by the employee's department head:

- 19 1. The day after Thanksgiving,
- 20 2. The working day before or the first working
21 day after Christmas (December 25th),
- 22 3. The working day before or the first working
23 day after New Year's Day (January 1st).

24 Q. January 15th, known as 'Dr. Martin Luther King, Jr.
25 Day' shall be a day of recognition only and shall not be a
26 legal holiday for any other purpose."

27 SECTION II: This Ordinance shall become effective immedi-
28 ately upon final passage to implement changes in the Memorandum

1 of Understanding for Fiscal Year 1982-83 pursuant to Government
2 Code Section 25123.


