AN ORDINANCE OF THE BOARD OF SUPERVISORS of the (Name of Governing Body)

COUNTY OF MARIPOSA authorizing an (Name of Public Agency)

AMENDMENT TO THE CONTRACT BETWEEN THE Board of Supervisors (Governing Body)

AND THE BOARD OF ADMINISTRATION OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM.

The Board of Supervisors of the County of Mariposa (Name of Governing Body) (Name of Public Agency) does ordain as follows:

SECTION 1. That an amendment to the Contract between the Board of Supervisors of the County of Mariposa and the Board of Administration, California Public Employees' Retirement System is hereby authorized, a copy of said amendment being attached hereto, marked "Exhibit A", and by such reference made a part hereof as though herein set out in full.

SECTION 2. The Chairman of the Board of Supervisors is hereby authorized, empowered, and directed to execute said amendment for and on behalf of said Agency.

SECTION 3. This Ordinance shall take effect 30 days after the date of its adoption, and prior to the expiration of 15 days from the passage thereof shall be published at least once in the Mariposa Gazette, a newspaper of general circulation, published and circulated in the County of Mariposa and thenceforth and thereafter the same shall be in full force and effect.

AMENDMENT TO CONTRACT BETWEEN THE  
BOARD OF ADMINISTRATION  
PUBLIC EMPLOYEES' RETIREMENT SYSTEM  
AND THE

BOARD OF SUPERVISORS  
OF THE  
COUNTY OF MARIPOSA

The Board of Administration, Public Employees' Retirement System, hereinafter referred to as Board and the BOARD OF SUPERVISORS of the COUNTY OF MARIPOSA, hereinafter referred to as Public Agency having entered into a contract under date of July 7, 1961, effective July 1, 1961, and as amended effective April 1, 1965, January 1, 1967, October 1, 1968, and April 17, 1973, and as provided by Chapters 170 and 316, Statutes of 1971, which provide for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

A. The following subparagraph shall be added to Paragraph 8 of said contract:

8. (d) Section 21222.2 (providing for increases in allowances to which the annual cost-of-living provisions apply, payable for time commencing on the first day of the calendar month coinciding with or next following the effective date of this amendment to or on account of persons retired or members deceased on or after January 1, 1971 but prior to July 1, 1971.

B. Paragraph 9 (b) (4) shall be added to said contract:

9. (b) With respect to local safety members, the public agency shall contribute the following percentages of monthly salaries earned as local safety members of said System:

(4) A lump sum of \$858.00 payable within 30 days of the effective date of this amendment on account of the provisions of Section 21222.2 of the Government Code.

C. This amendment shall be attached to said contract and shall be effective on the 21st day of March, 1974.
