2 February, 1963, as a matter of administrative  
3 convenience."

4 B. Sub-section (j) of Section 10 is hereby amended to read  
5 as follows:

6 "(j) The Road Commissioner shall receive a salary of  
7 \$8,580.00 per annum."

8 SECTION II: The wage and salary increases provided by this  
9 ordinance shall go into effect as of March 1, 1963.

10 SECTION III: The Board of Supervisors shall by minute order assign  
11 steps in the classifications above-mentioned, other than those  
12 affecting the road department, so as to effect wage and salary  
13 increases for employees of those various departments as outlined in  
14 letters from said department heads filed with the Board of Super-  
15 visors on March 5, 1963, and March 11, 1963.

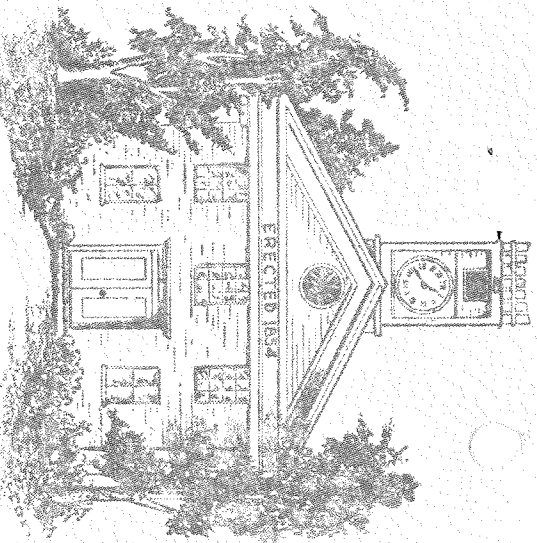
