RESOLUTION

WHEREAS:

- A. The State of California, Department of Housing and Community Development, Division of Community Affairs, issued a Notice of Funding Availability (NOFA) for the Emergency Housing and Assistance Program (EHAP) (Round #EHAP-VI); and
- B. The Mariposa County Housing and Community Development Agency is a local government agency which is eligible and wishes to apply for and receive an EHAP grant;

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Board of Supervisors of Mariposa County hereby authorizes the Director of Human Services to apply for an EHAP grant in an amount not more than the maximum amount permitted by the NOFA, and in accordance with the program statute and Regulations.
- 2. If the grant application authorized by this resolution is approved, the Mariposa County Housing and Community Development Agency hereby agrees to use the EHAP funds for eligible activities in the manner presented in the application as approved by the Department and in accordance with the program statute (Health and Safety Code Section 50800 – 50806.5) and Regulations (Title 25, Division 1, Chapter 7, Subchapter 12, Sections 7950 through 7976 of the California Code of Regulations), and the Standard Agreement.
- 3. If the grant application authorized by this resolution is approved, the Director of Human Services is authorized to sign the Standard Agreement and any subsequent amendments with the Department for the purposes of this grant.
