

MARIPOSA COUNTY RESOLUTION NUMBER 98-231

A RESOLUTION RECOGNIZING RODERIC B. "ROD" SINCLAIR
FOR HIS SERVICE TO THE COUNTY OF MARIPOSA

WHEREAS, RODERIC B. "ROD" SINCLAIR was hired by the Mariposa County Sheriff's Department on September 13, 1971 and served with distinction until January 30, 1998; and

WHEREAS, at the time ROD was hired the population of Mariposa County was approximately 6,300 necessitating nine Deputies to serve the entire County of Mariposa; and

WHEREAS, when ROD was hired he supplied his own weapon; and

WHEREAS, ROD has served under four Sheriffs and one acting Sheriff; and

WHEREAS, ROD was hired before the days of required "overtime" and ROD patrolled the entire County putting in many long days, over and above the eight-hour shift for which he was paid; and

WHEREAS, ROD rose through the ranks from a Patrol Deputy to Captain; and

WHEREAS, ROD's employment began before the age of computers and during his tenure he subsequently worked closely with the Mariposa County Technical Services Director to bring full automation to the Sheriff's Department; and

WHEREAS, ROD was instrumental in obtaining the boating program in Mariposa County and was a supervisor of the program for many years; and

WHEREAS, ROD was instrumental in designing the communications/operations of the Sheriff's presence at the annual Mariposa County Fair; and

WHEREAS, ROD served as the entire "Bomb Squad" for the Mariposa County Sheriff's Department; and


WHEREAS, ROD served as the Project Coordinator on behalf of the Sheriff's Department when the Mariposa County Sheriff's Administration Building was constructed; and

WHEREAS, on June 22, 1982, ROD received a "Supervisory Certificate" and on December 24, 1987, received a "Management Certificate" from the Commission on Peace Officers Standards and Training; and

WHEREAS, ROD is to be commended for his twenty-seven years of dedicated and loyal service to the citizens of Mariposa County.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Mariposa County, a political subdivision of the State of California, hereby recognizes RODERIC B. "ROD" SINCLAIR for his service to the County and citizens of Mariposa, and he is warmly wished a long and happy retirement.
