RE: Approve MOU with NPS Yosemite National Park for Wawona

RECOMMENDATION AND JUSTIFICATION:

Approve a Memorandum of Understanding (MOU) Between the County of Mariposa and United States Department of Interior National Park Service Yosemite National Park for Wawona (Agreement Number M-YOSERV003); and Authorize the Board of Supervisors Chair to Sign the MOU.

The current MOU was drafted and executed in 1987, and doesn't reflect the current status of National Park Service-County responsibilities for providing shared public services in Wawona. There have been subsequent Agreements executed for:

"Responsibilities for Law Enforcement" (2012),
"Providing and Maintaining Public Library Services" (1996),
"Fire Protection" (2011),
"Emergency Medical Service" (2011), and
"Behavioral Health Care" (2015).

The proposed document will rescind and replace the current MOU.

The Superintendent, Yosemite National Park supports the MOU document.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Alternatives: Modify text in draft MOU. Modified text would have to be approved by County Counsel and the Superintendent, Yosemite National Park.

Negative Action: If the MOU is not approved, the current MOU from 1987 will remain in effect. The 1987 MOU does not reflect the current status of responsibilities for some community services.

FINANCIAL IMPACT:

No change in current financial obligations for county services in Wawona.
