RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No X)

Resolution authorizing Mariposa Little League to construct two batting cages (14' x 65') at Woodland Park. The land is currently not in use (see Attachments 1 through 3). The league would be responsible for all permits, construction and maintenance. A similar request may be made for Catheys Valley Park if land availability can be ascertained. Batting cages will reduce congestion on practice fields.

The Board has taken numerous actions on behalf of Mariposa Little League. The County currently provides a \$1000 grant to the League and provides maintenance support to the youngsters in the program.

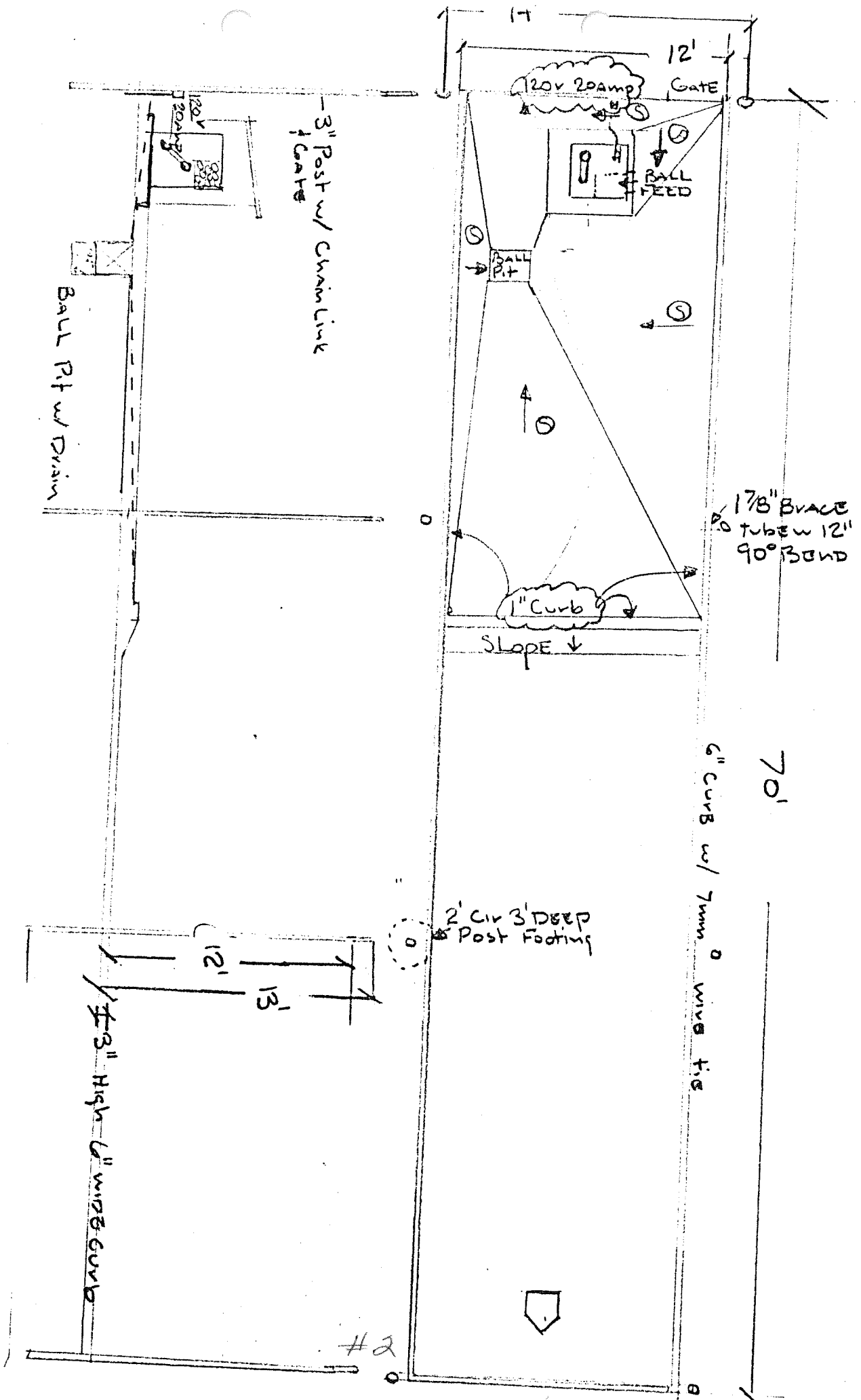

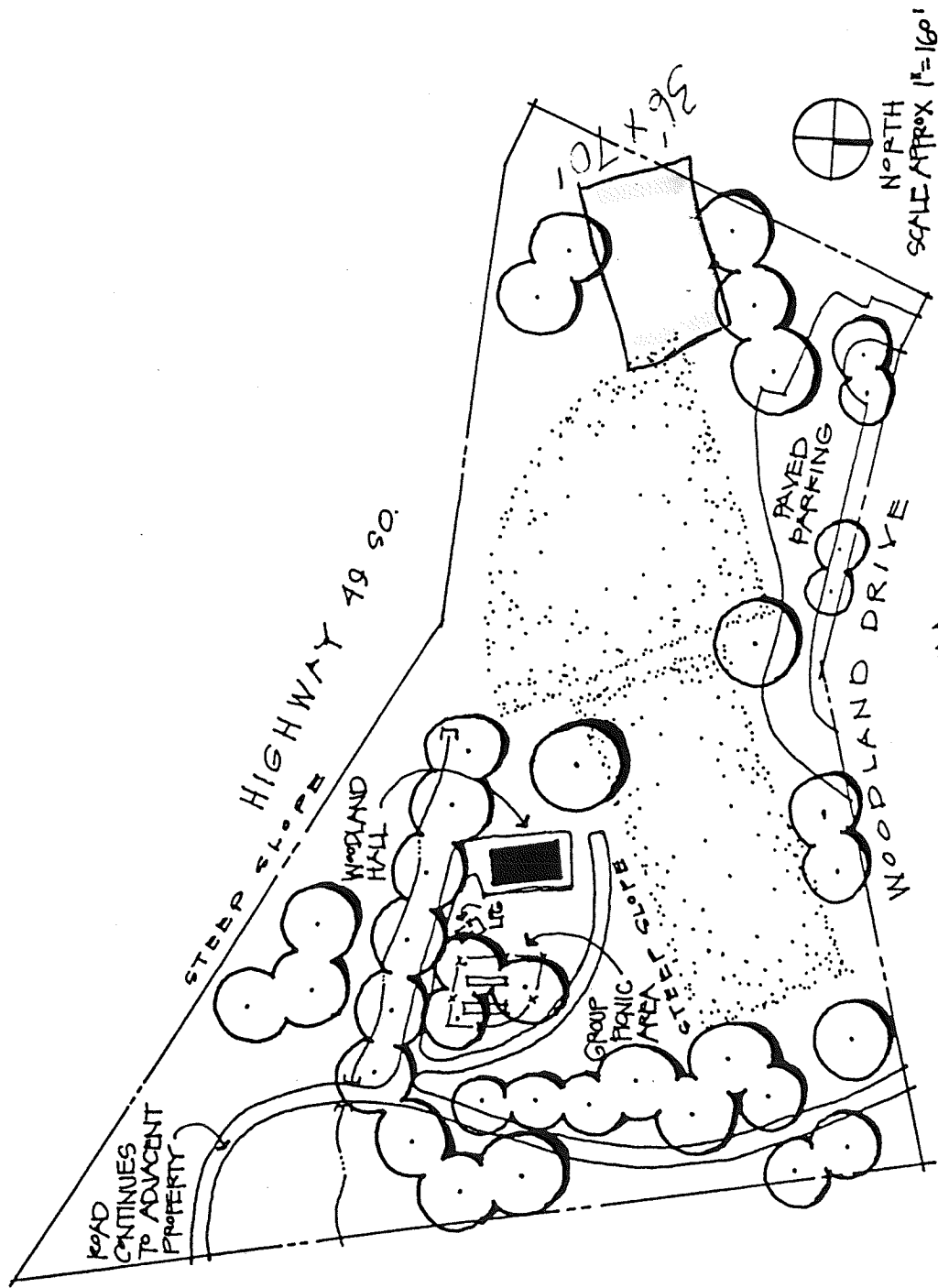

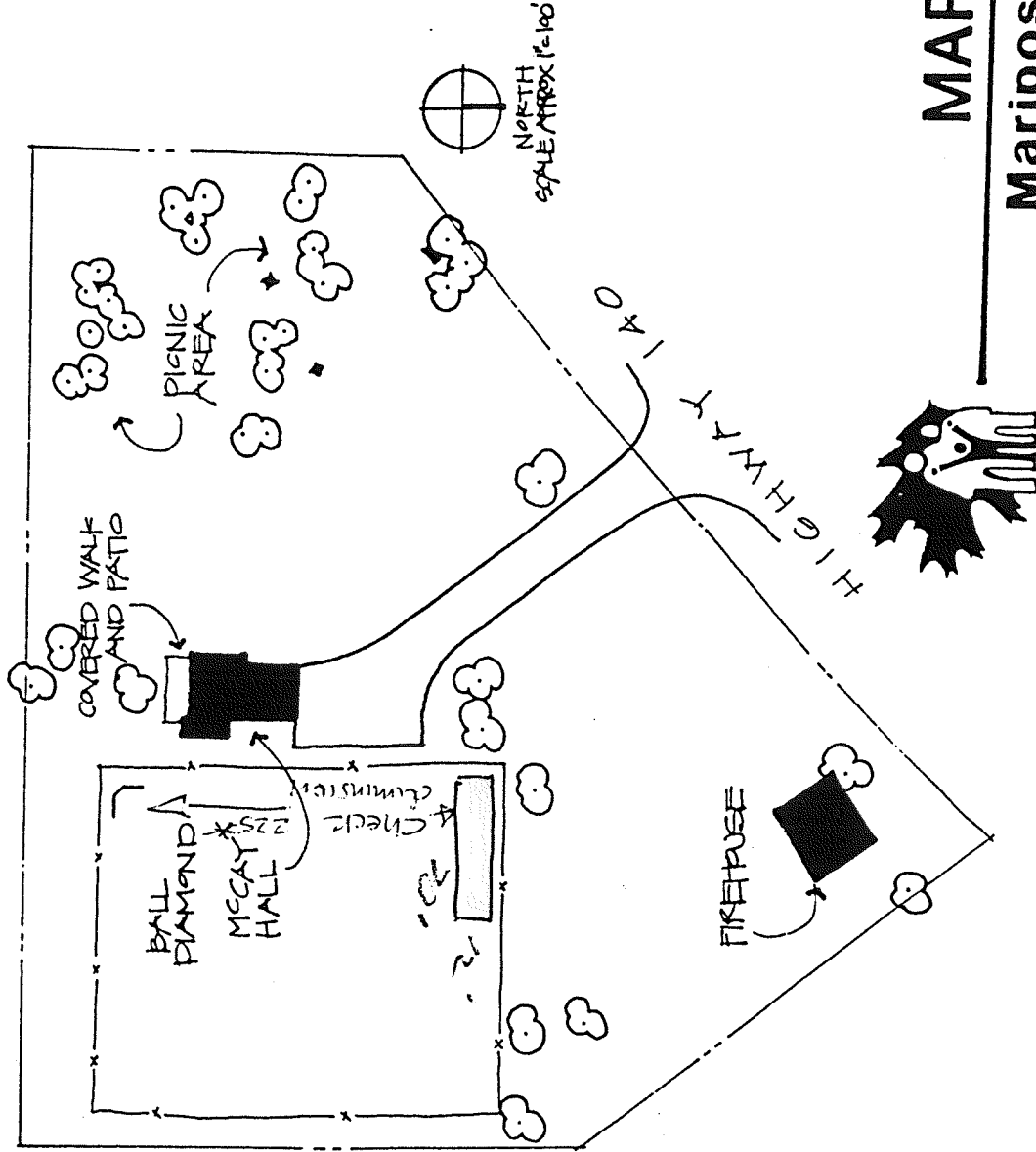
