Resolution authorizing volunteers in Coulterville to conduct a landscaping project at the old Coulterville jail.

The scope of this project is represented in Attachment #1. The project will likely cost \$300 to \$500 due to the installation of water line across pavement. The bill for the use of the water is currently being paid by the County. The increase in usage after installation of the drip irrigation system would be minimal.

The volunteers would be required to sign a Volunteer Statement that has been provided by County Counsel (Attachment #2).

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The old Coulterville jail is a small historic building with no landscaping. The volunteer group highlight this structure with aesthetic landscaping. Public Works supports this project and will provide oversight and assistance.

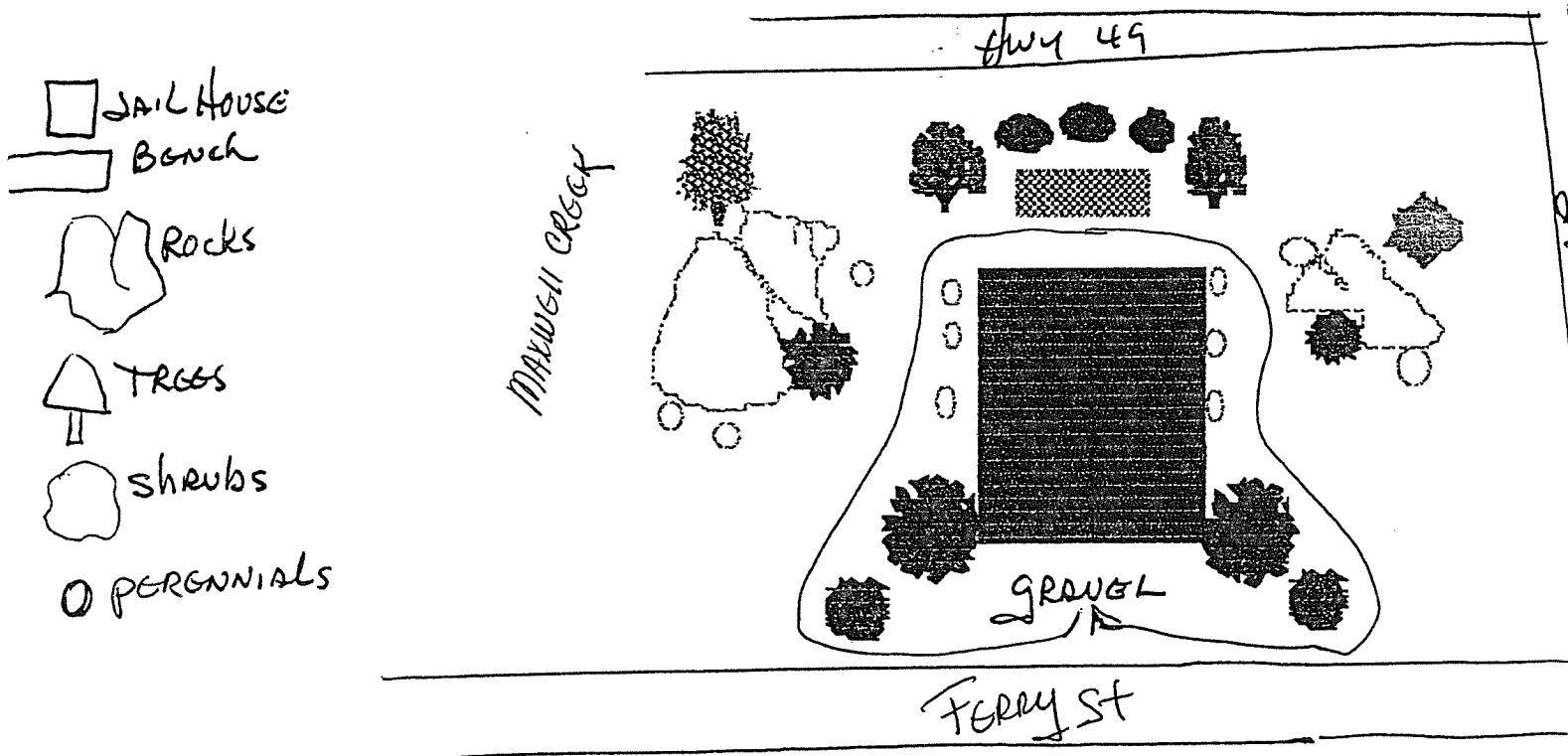
