WHEREAS, BILL BONDSHU has served three consecutive one-year terms as Chairman of the Mariposa County Emergency Medical Care Committee; and


WHEREAS, under the leadership of BILL, many strides forward have been made for the delivery of quality emergency medical services in Mariposa County, including, but not limited to:


- Implementing the Emergency Medical Dispatch System
