Conduct a public hearing and adopt a resolution to reaffirm fees charged for FY 98/99 for Yosemite West Maintenance District for sewer, water, roads and standby. NO CHANGE IS RECOMMENDED.

Government Code Section 25210.77b requires the Board to reaffirm annually the standby fees for sewer and water, not to exceed \$30 per acre or \$30 per parcel less than one acre. This is an annual fee. NO CHANGE IS RECOMMENDED. Currently, all standby charges are set at \$30 annually and billed accordingly.
