The Board provided additional funding for this project in July, 1998 as part of the FY 1998-99 Proposed Budget.

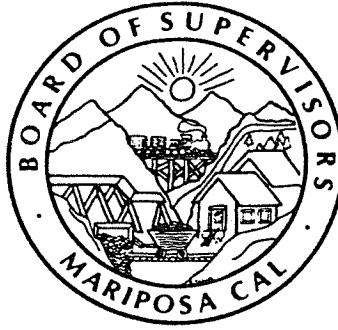
