RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: YES () NO (X))

Authorize the Fire Department to acquire 2 surplus Sheriff's Department blazers for use as medical response squads. These units would be placed at Greeley Hill station and Midpines Fire station. The areas served by Greeley Hill company and Midpines company cover remote and non-maintained travel routes. Currently, medical calls require a fire engine response at a cost of \$2.50/mile. These squads operate at a cost of \$.50 per mile. Further, they save on wear and tear of the fire engines. This program was discussed with the Board during hearings on the proposed new engine acquisition, however, no definitive action was taken.



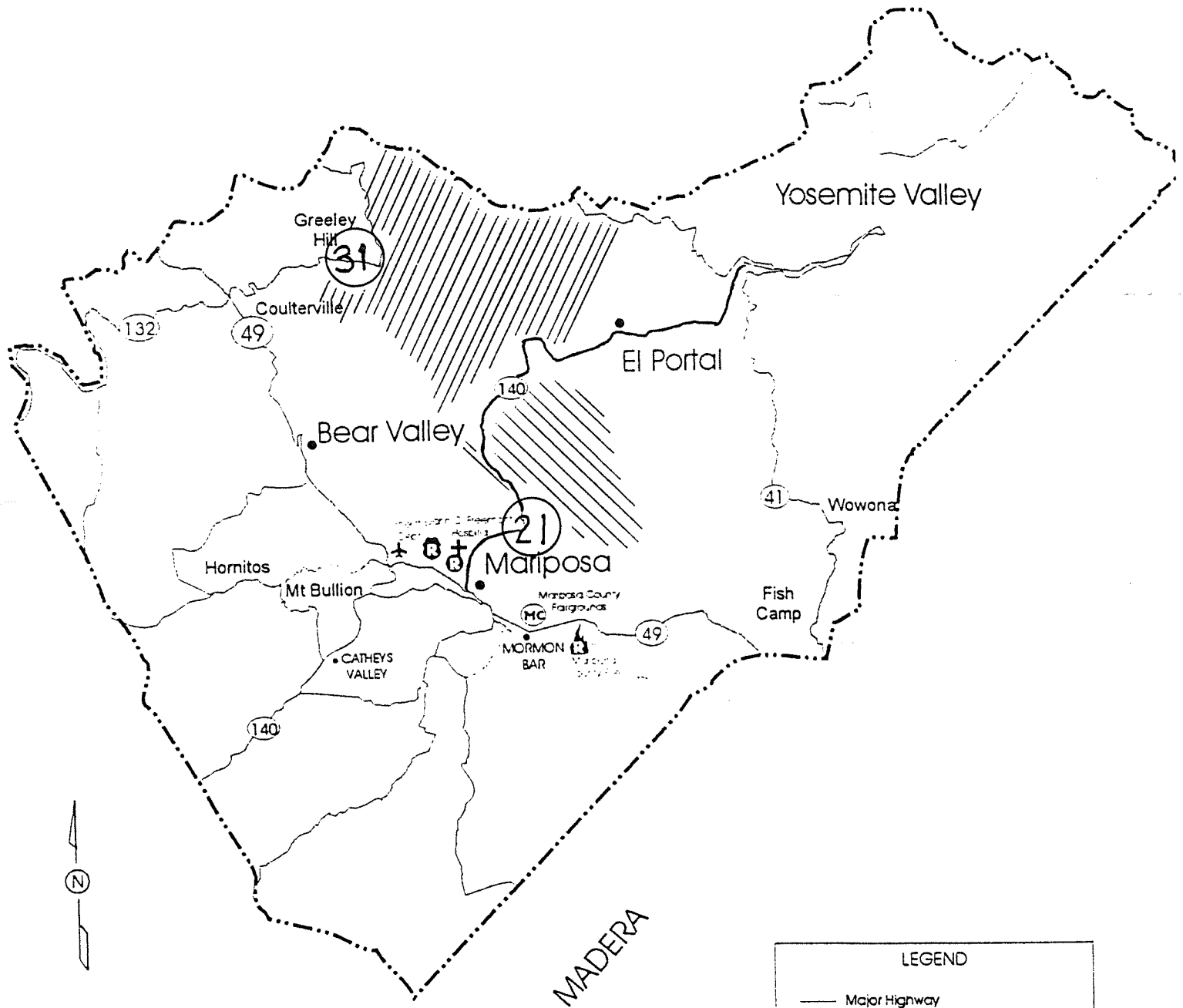
ACTION AND VOTE:
