RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes___ No_X_)

Resolution authorizing a budgetary fund transfer from jury and witness Expense (\$2,295) to transportation and travel, for reimbursement of child abduction and jury expenses.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The District Attorney's Office is in receipt of a Circle Three Travel invoice (\$977.96) for plane tickets concerning a child abduction matter which cannot be submitted until this requested fund transfer is authorized, in order to prevent a negative balance in the Criminal Division's transportation and travel line item. On July 18, 1996, the transportation and travel line item incurred witness transportation expenses in the amount of \$1,230.00, in People vs. Scott Richards. This particular matter required a District Attorney representative and a Deputy Sheriff to travel to New Mexico. On December 15, 1996, the transportation and travel line item incurred child abduction transportation expenses in the amount of \$1,064.81, requiring a District Attorney representative and a Deputy Sheriff to transport victims in a child abduction matter from Montana. Child abduction expenses (\$1,064.81) are reimbursable under SB 90.
