MARIPOSA COUNTY RESOLUTION NUMBER 97-186

A RESOLUTION RECOGNIZING LEE HANNA FOR HER SERVICE TO THE COUNTY OF MARIPOSA

WHEREAS, LEE HANNA has devoted countless hours to serving the community as a dedicated County employee since April of 1981; and

WHEREAS, LEE has served in several responsible positions, including Manager of the Mariposa County Mineral Exhibit, and most recently as Program Assistant for the Department of Human Services where she was responsible for operations in Eligibility Services and the Special Investigation/Fraud Prevention Unit where she was instrumental in establishing outstanding programs; and

WHEREAS, while fulfilling her duties at the Department of Human Services, LEE made the following contributions and accomplishments: Performed a number of additional duties, including coordinating divisional staff, development, training, and administering the Department's Civil Rights Plan in compliance with Federal law; represented the Human Services Director on several statewide committees involved with such complex issues as welfare reform redesign where she did an outstanding job advocating Mariposa County interests; served as chairperson for the Mariposa County Perinatal Coalition for Substance Abuse Prevention; assisted in developing the department's strategies for successfully implementing such important changes as the State/County realignment of Social Services programs and the State Automated Welfare System (ISAWS) for Mariposa County, which has been an exemplary process completed by Lee and her staff that will benefit County operations well into the next century; LEE and her staff have received numerous commendations from Federal and State observers for their outstanding program achievements, including establishing a program accuracy rate of over 98% which exceeds required standards and was recognized as among the very best in the State bringing credit to the County for outstanding program practices; and

WHEREAS, LEE has also been active in many community activities, including serving as president of the Mariposa Soroptimist Club.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Mariposa County, a political subdivision of the State of California, hereby recognizes LEE HANNA for her service to the County and citizens of Mariposa, and she is warmly wished a long and happy retirement.
