
WHEREAS, NANCY RADANOVICH-STRATHEARN helps make Mariposa County a better and safer place to live through her hard work and dedication.

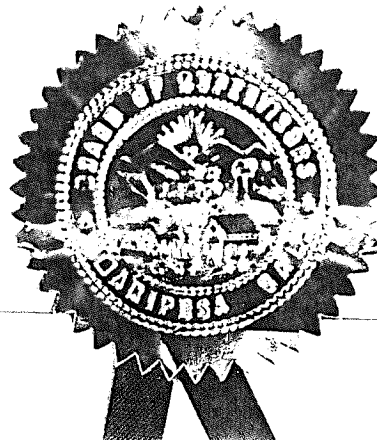




WHEREAS, TOM DOWLAN helps make Mariposa County a better and safer place to live through his hard work and dedication.




