RE: Donation of Utility Vehicle to Fire Department.

In August 1996, the department responded to the Hunters Valley Fire and ultimately the Stumpfield Fire. The Fire Chief responded in the only county fire emergency vehicle. While trained individuals were available, a second command vehicle was not.

Following the January Flood emergency, the chief was committed in El Portal and a second vehicle was not available for trained duty officers to respond to county incidents not covered by the CDF.

To adequately serve the county, and to utilize our own duty officers (trained volunteer captains), we are in need of a second vehicle. Additionally, the Fire Chief has elected to remain in county and send our staff on Strike Team assignments out of county.

The Fire Chief requested a surplus vehicle from those units being phase out by the Sheriff but personnel increases within that department eliminated any extra vehicles. George Cordingly has offered to donate a Chevrolet S-10 Blazer to the fire department for use as a second command vehicle. The fire department has contacted the Public Works department and secured concurrence.
