Accept \$7131 in unanticipated revenue from the State of California OES for the Strike Team services provided to Los Angeles County on the Calabasas Incident. Volunteer firefighters staffed the OES Engine and past practice provides compensation at a rate of 85% of personnel costs.

The Budget Action form details this payment of the firefighters at \$6061 and a request to purchase a handheld radio at a cost of \$800, for use by the Strike Team. The balance of \$270 is to be applied to the General Contingency.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Board has accepted Office of Emergency Services compensation in the past and compensated the firefighters at the rate of 85% of personnel funding.
