**RECOMMENDED ACTION AND JUSTIFICATION:**

(Policy Item: Yes    No   X  )

Public Works recommends that the Board of Supervisors adopt this Resolution of Intention to Vacate a portion of ELEVENTH STREET in the town of Mariposa with the following findings:

1. It is the Board's intention to vacate a portion of Eleventh Street in the town of Mariposa.
2. This procedure is being conducted pursuant to Section 8320 of the California Streets and Highways Code.
3. The portion of Eleventh Street to be vacated is described as: Beginning at the intersection of the westerly line of Jones Street with the northerly line of Eleventh Street; thence along the northerly line of Eleventh Street south 53° 56' west 117.5 feet; thence leaving said northerly line, south 36° 04' east, 50.00 feet to a point on the southerly line of Eleventh Street; thence north 53° 56' east along the southerly line of eleventh Street, 117.5 feet to the westerly line of Jones Street; thence north 36° 04' west along the westerly line of Jones Street, 50.00 feet to the point of beginning.
4. Set a public hearing on this matter for September 16, 1997 at 9:30 A.M.

State Law requires that the Board adopt a Resolution of Intention to Vacate and set a public hearing. The intention to vacate must also be advertised in a news paper of general circulation and notices must be posted along the road to be vacated.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The portion of Eleventh Street affected by this resolution is proposed to become part of the parking lot for the new Government Center. When the parking lot is completed, Eleventh Street will no longer go through from Bullion Street to Jones Street. This resolution does not propose to vacate the portion of Eleventh Street along the frontage of the privately owned parcel across Eleventh Street from the proposed Government Center. Only the area where the County owns the property on both sides of Eleventh Street is to be vacated.

If this resolution is not adopted, Eleventh Street in the area of the proposed parking lot will continue to be a road within the County Maintained Road System.

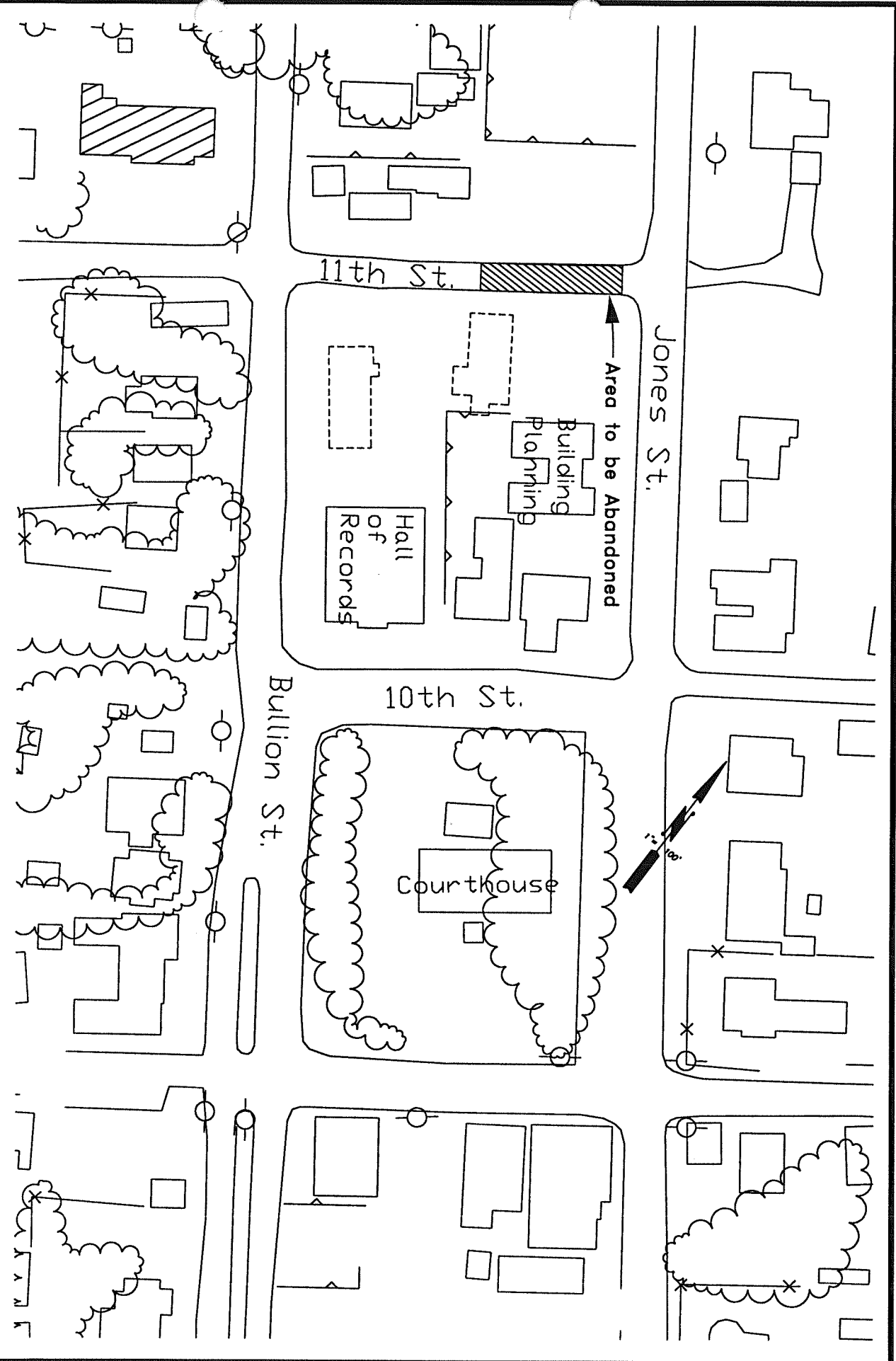
