

RECOMMENDED ACTION AND JUSTIFICATION:

Request that the County donate a used culvert for Valley View Drive, for the purpose of preventing road wash-out due to runoff. The existing culvert is not large enough to accommodate the amount of run off. Currently the runoff is causing soil erosion and deterioration of the existing road. This is the only entrance and exit for this area, and when the road washes out this hinders emergency vehicles from gaining access to the area.
