WHEREAS, JAN is hard working, efficient and dependable; and


WHEREAS, JAN's professional and personal contributions help make Mariposa County a better place; and


WHEREAS, JAN has devoted long hours to many community services and activities as a member of the Mariposa County Chamber of Commerce; and


WHEREAS, JAN is best described as a man behind the scenes that makes things happen.




