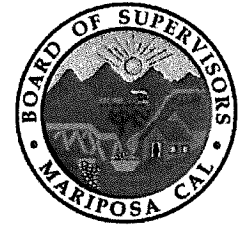

### **RECOMMENDATION AND JUSTIFICATION:**

Approve Certified Farmers Market Inspections Program Cooperative Agreement No. 16-0167-SA for Fiscal Year 2016/2017 with the California Department of Food and Agriculture (CDFA); and Authorize the Chairman of the Board of Supervisors to Sign the Agreement.

This cooperative agreement with the CDFA is for work performed in Mariposa County in the enforcement of the Certified Farmers Market (CFM) Program. Funds will be received for certified farmers market inspections and production site inspections of certified producers as well as producer and market investigations.

The total available in Fiscal Year 2016/2017 for this agreement is \$1,175.00.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Certified Farmers Market Inspections Program Cooperative Agreement for Fiscal Year 2015/2016 was approved by Resolution No. 15-318.

### **ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

No funds will be received for certified farmers market inspections or certified producer production site inspections or investigations performed.
