The Board has authorized LIHEAP Weatherization and Energy Crisis Intervention Program services for the past 11 years. Last year, the State Department of Economic Opportunity/Community Services and Development implemented a regionalization and restructure proposal that dramatically reduced funds to rural areas. While agencies are continuing to rectify the situation, services are not currently provided.
