RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ NoX ___)
ADOPT RESOLUTION WAIVING THE HIRING FREEZE AND AUTHORIZING THE SHERIFF TO REPLACE TWO VACANT POSITIONS. (ONE IN THE JAIL AND ONE IN PATROL) WE HAVE LOST THE SERVICES OF ONE JAIL OFFICER AND ONE RESIDENT DEPUTY ON THE NORTH SIDE OF THE COUNTY. AS THE BOARD IS AWARE THE JAIL IS "MINIMUM STAFFED" AND ANY MISSING STAFF PUTS BOTH THE JAIL OFFICERS AND THE INMATES AT RISK SHOULD AN INCIDENT OCCUR. FURTHER, LACK OF STAFF CREATES MORE OVERTIME. THE PATROL DIVISION, LIKEWISE IS PRESSED TO COVER ITS COMMITMENT AND WE ARE INCURRING OVERTIME WHEN WE OPERATE SHORTHANDED IN ADDITION TO CREATING POTENTIAL OFFICER SAFETY ISSUES. (IE: LACK OF "BACKUP" ON VIOLENT CALLS ETC).
