RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes\_\_\_ No X)

Resolution adopting bid and contract documents for the 1996 Overlay Program on Various County Roads, Public Works Project Number PW 95-30, authorizing advertisement for sealed bids, set a bid opening date for Thursday, May 2 at 10:30 a.m. and authorizing the Public Works Director to execute a contract with the lowest responsible bidder.

Bid documents are essentially the same as those prepared for the 1994 overlay program. Improvements developed as a result of that year's experience are incorporated in the technical specifications. We have been advised by contractors that we can get better bids by advertising early in the season.

This is a formal bid in accordance with Mariposa County Ordinance #886 and the Uniform Construction Cost Accounting Act, since the bid is expected to be greater than \$75,000.

This project will result in the improvement of approximately 9.4 miles of County roads, including portions of Triangle, Merced Falls, Schoolhouse, Wass, and Tip Top Roads (see Attachment #1). Summer 1996 road maintenance activities will include the overlay program at an estimated cost of \$400,000, as explained in the earlier Board item detailing the overall summer road program. Hospital Road will be included as an additive alternative. If the 12" water line installation has been completed in time to schedule pavement construction, including it as part of the subject contract will be the most efficient way to complete it.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The 1994 overlay program was for approximately 8.3 miles at a cost of \$350,000.

**LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

No action will delay completion of this summer road construction program. This type of work needs to be completed during warm summer months.
